The split club of \$267 was won by Lion President Henry at our last meeting! A new split club will begin at our next meeting where any ace drawn will win the pot.





Peace Poster chair Paul Bassette Honored our Peace Poster contest 1st and 2nd place winners at our may 23rd dinner meeting. Lion Paul gave a quick background on the history of The Peace Poster contest, which has been conducted for the past 30 years. The contest is for young people ages 11-13. This year's theme was "The Future of Peace". District level winners go on to the State level winners to many nations throughout the world. We had 23 Peace Posters submitted this year. The judging criteria are based on use of theme, artistic ability and originality. Second place \$50 winner Miss Madelyn Montes is seen above while Miss Alexandra Jensen, first place \$100 winner, is shown at the left. Both students are from Connor Middle School. The posters will be display for 1 year at the Grand Island Public Library. We also had 2 honorable mention winners that each received \$25.

Tammy Owen, Director of The Olmsted Center for Sight spoke to us at our May 9th meeting about the programs at the center: Background on Olmsted: It used to be the Blind Association of WNY. The center serves persons from infancy to the end of life. Services range from the Pre-school that has now transitioned the running of the school to Buffalo Hearing and Speech Center. It has a career program for unemployed adults training them in many different areas from hospitality and IT. It has a low vision Clinic and rehabilitation services

Gary Wagner: A client of the Olmsted Center spoke about the benefits that he received from the Olmsted Center for Sight as he lost his vision. The agency has helped him move upward in the system and he is currently the director at the VA in the calling center. Gary wants to help people find employment who are blind and hire persons who are blind. There is a 70% unemployment rate for those who are legally blind.

Connect 211 is a program providing access to information on local and national health and human services.

Our annual donation to The Olmsted Center was presented to Tammy and Gary after their presentations.




