1/5	Ransom Rd.	Snowmobile Operation	Complainant states that several snowmobiles were riding on school property. Deputies checked the area but were unable to locate the snowmobiles.

1/7	Whitehaven Rd.	Suspicious Person	Complainant states that a male subject was stumbling down the roadway. Deputies located the subject and advised him.
1/7	Oak Ridge Rd.	Fraud	Complainant states that an unknown person(s) made fraudulent charges on her credit card at an out of state Walmart.

1/7	Ferry Rd.	Parking Violation	Complainant states that a vehicle was parked in the roadway and obstructing traffic. Deputies located the owner of the vehicle and advised him to remove it from the roadway.
1/8	Grand Island Blvd.	Suspicious Vehicle	Deputies located a suspicious vehicle in the parking lot of a closed business late at night. Deputies spoke to the owner of the vehicle, who was an employee that was closing up for the night.
1/8	Love Rd.	Suspicious Vehicle	Complainant states that a suspicious vehicle was parked in the Sunoco parking lot late at night. Deputies located the vehicle but no persons were seen in the area. No damage was observed to the building.
