



## Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 199 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

1/3	Ransom Rd.	Suspicious Incident	The complainant states that a small child was playing outside of her apartment complex and did not appear to be supervised. Deputies checked the complex and determined the complaint was unfounded.

1/4	Warner Dr.	Suspicious Incident	The complainant states it appeared as though an unknown person(s) was in his brother's car and honking the horn during the late hours of the night. Deputies checked and determined the vehicle horn was malfunctioning.

1/5	Sturbridge La.	Youth Activity	The complainant states that several youths in the neighborhood were ringing door bells then running away. Deputies checked the area but were unable to locate any youths involved.

Drunk Driving / Unlawful Possession of Marijuana	Following a traffic stop, Deputies arrested 33 y/o Pascual Munoz-Ortiz of Grand Island for Driving While Intoxicated, Unlawful Possession of Marijuana (Violation) and other traffic infractions. Munoz-Ortiz refused to submit a sample of his breath for chemical analysis. Munoz-Ortiz was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.
1/9	Ward Park Rd.	Parking Complaint	The complainant states that a vehicle was parked in a lane of traffic. Deputies checked and determined the vehicle was parked as close as possible to the curb and was not obstructing traffic.
