

## **Erie County Sheriffs Office Media Release Summary**

The Erie County Sheriff's Office responded to 182 calls the week of this report. Below is a sampling of the noteworthy incidents on **<u>Grand Island</u>**.

12/21	Fix Rd.	Property Found	While Deputies were investigating a nearby complaint, they located a bicycle in the brush. Bicycle was brought to the Grand Island Substation.
