

Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 153 calls the week of this report. Below is a sampling of the noteworthy incidents on **<u>Grand Island</u>**.

1/9	Grand Island Blvd.	Noise Complaint	The complainant states that a neighbor in a nearby apartment was banging on the walls during the late hours of the night. Deputies advised the subject.
1/9	Oak Harbor Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke with the occupants of the residence and determined the phone was malfunctioning.
1/9	Grand Island Blvd.	Residential Burglary	The complainant states that a known subject was pounding on his apartment door during the late hours of the night and then broke the door and entered unlawfully. Deputies located the subject who was still on location and their investigation led to the arrest of 18 y/o Shane Kinney of Grand Island for Burglary 2 nd Degree (C Felony), Criminal Mischief 3 rd Degree (E Felony). Kinney was also charged with Obstruction of Governmental Administration 2 nd Degree (Class A Misdemeanor) and Assault 2 nd Degree (Class D Felony) after he assaulted a Deputy during his arrest.
1/9	Whitehaven Rd.	Burglary	Patrol received a complaint from Employees of Ace Hardware who stated they arrived to open the store for business and found a smashed window. Deputies checked the store but found no persons inside. During the course of the investigation and review of the surveillance tapes it was determined Shane Kinney was the perpetrator in this Burglary as well. Kinney was already in custody on the above complaint and was additionally charged with Burglary 3 rd Degree (Class D Felony), Criminal Mischief 3 rd (Class E Felony) and Petit Larceny (Class A Misdemeanor). Kinney was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.
1/9	Revere Rd.	Criminal Mischief	The complainant states that sometime during the night, an unknown person(s) smashed the rear window on his car.
1/10	Oakridge Rd.	Suspicious Person	The complainant states that several subjects were walking up and down the street looking into cars during the late hours of the night. Deputies located the subjects

			and determined they were playing hide and seek.
1/10	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
1/11	Industrial Dr.	Burglary	Deputies responded to a report of a burglary alarm at Executive Carpet Cleaners. Upon arrival they located a few broken windows and a broken garage door. The area and business were searched but no persons were found. Several items were reported missing. Investigation Ongoing.
1/12	Grand Island Blvd.	Traffic Arrest	Following a traffic stop, Deputies arrested 24 y/o Danielle Bush of Grand Island for Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor) and other traffic infractions after a DMV check showed her license was currently suspended. Bush was issued an appearance ticket returnable to the Town of Grand Island Court.
1/12	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
1/12	Baseline Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
1/12	Pin Oak Cr.	Accident Hit & Run	The complainant states that an unknown vehicle struck her mailbox and fled the scene.
1/12	Bedell Rd.	Marijuana Possession / Narcotics Arrest	Following an investigation of a vehicle stuck in the snow in Veterans Park, Deputies arrested 19 y/o Ryan Arsenault of Grand Island for Unlawful Possession of Marijuana (Violation) and Criminal Possession of a Controlled Substance 7 th Degree (Class A Misdemeanor). Arsenault was issued an appearance
1/13	Grand Island Blvd.	Drunk Driving	ticket returnable to the Town of Grand Island Court. Following a traffic stop, Deputies arrested 21 y/o Robert Rovison of Grand Island for Driving While Intoxicated and other traffic infractions. Rovison registered a .08% B.A.C. after submitting a sample of his breath for chemical analysis. Rovison was issued an appearance ticket returnable to the Town of Grand Island Court and released to the custody of a sober 3 rd party.
1/13	Whitehaven Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
1/14	Grand Island Blvd.	Fight	The complainant states that she was driving on Grand Island Blvd. and observed 2 males that looked like they were about to fight. Deputies located both males nearby and advised them. The males left without incident and denied any fight had taken place.
1/14	East River Rd.	Suspicious Incident	Deputies located a vehicle with all 4 car doors open and no one around during the late evening hours. Patrol made contact with the owner and determined the doors were an oversight.
1/14	Whitehaven Rd.	Marijuana Possession	Following a traffic stop, Deputies arrested 29 y/o Christine Gilbert of Grand Island for Unlawful Possession of Marijuana (Violation). Gilbert was issued an appearance ticket returnable to the Town of Grand Island Court.
1/15	Love Rd.	Animal Loose	The complainant states that 2 dogs were running loose in

			the area. The Dog Control Officer was notified.
1/15	Baseline Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
