The Erie County Sheriff's Office responded to 160 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

1/10	Baseline Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
1/10	Baseline Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident involving a mailbox. No injuries were reported.
1/10	Broadway	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
1/11	Whitehaven Rd.	Burglary	The complainant states that sometime during the past day, an unknown person(s) broke into the Trinity United Methodist Church and caused a moderate amount of damage. Investigation Ongoing.
1/11	Monica Rd.	Residential Fire	Deputies assisted the Grand Island Fire Department with a report of a house fire. The occupant of the house was able to escape with only minor injuries. The Erie County Sheriffs Fire Investigation Unit responded to the scene to assist with the investigation.
1/12	Grand Island Blvd.	Suspicious Person with Vehicle	The complainant states that 3 male subjects were sitting in a vehicle parked near Adrian's Custard & Beef during the late hours of the night. Deputies located the males and determined they were eating food they had purchased at a nearby restaurant.
1/12	Grand Island Blvd.	Suspicious Person	The complainant states an elderly male was walking in the roadway and attempting to stop traffic. Deputies checked the area but were unable to locate the subject.
1/12	Baseline Rd.	Suspicious Incident	The complainant states that several subjects were at a residence that had recently been the scene of a fire. Deputies located the subjects and determined they worked for the insurance company.
1/12	East River Rd.	Suspicious Vehicle	The complainant states that a vehicle was parked on the service road near the I-190. Deputies checked the area but were unable to locate the vehicle by the description given.
1/12	Baseline Rd.	Burglary	The complainant states that sometime during the past day, an unknown person(s) broke into St Stephens Church and damaged items while inside. Several items were also reported stolen. Investigation Ongoing.

1/12	West Oakfield Rd.	Parking Complaint	The complainant states that a snowmobile trailer was blocking the roadway and impeding the flow of traffic. Deputies checked and determined the complaint to be unfounded.
1/12	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of McDonald's. No injuries were reported.
1/13	Jenell Dr.	Residential Burglary	The complainant states she came home from work and found that her residence was broken into and ransacked sometime during the day. Several items were reported missing. Investigation Ongoing.
1/13	First St.	Snowball Complaint	The complainant states that while he was driving, two kids were hiding on the side of the road and threw a snowball at his vehicle. No damage was observed on the vehicle. Deputies checked the area but were unable to locate the youths by the description given.
1/13	Long Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
1/14	Grand Island Blvd.	Suspicious Person with Vehicle	Deputies located an occupied vehicle parked outside of Burger King after closing hours late at night. The occupants were determined to be employees of the business who were finishing up cleaning.
1/15	Long Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. The driver of the vehicle was transported to a local hospital with seemingly non-life threatening injuries.
1/15	Center Ct. North	Suspicious Incident	The complainant states that his vehicle was damaged by construction workers that had completed work on the garages attached to his apartment. Deputies were unable to see any damage to the vehicle.
1/15	Marjorie Dr.	Trespass	The complainant states that a male subject was knocking on her front door during the late evening hours. The subject then went into her backyard and was knocking on the rear windows and door. Deputies located the subject at the residence. Their investigation led to the arrest of 31 y/o Dandre Robinson of Kenmore for Criminal Trespass 3 rd Degree (Class B Misdemeanor). Robinson was issued an appearance ticket returnable to the Town of Grand Island Court.
1/15	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
1/16	West River Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
1/16	Grand Island Blvd.	Harassment	The complainant states that a known subject harassed her while she was at Tops in violation of a duly served order of protection. Deputies investigation led to the arrest of 38 y/o Michael Paul of Grand Island for Criminal Contempt 2 nd Degree (Class A Misdemeanor) and Harassment 2 nd Degree (Violation). Paul was issued an appearance ticket returnable to the Town of Grand Island Court.
1/16	Ward Park Rd.	Animal Complaint	The complainant states that his dog was stuck in a chain link fence in the yard. The Dog Control Officer was

			notified.
1/16	Grand Island Blvd.	Customer Trouble	Employees of Laundry Lounge state that a male subject who had previously harassed patrons and employees was on location. Deputies located the subject and advised him that he was not welcome at the business anymore. The subject left without incident.
1/16	Revere Rd.	Suspicious Incident	The complainant states that she could see footprints in the snow in her yard. Deputies checked and determined the prints were made by an unknown type of animal.
