



Erie County Sheriff's Office Media Release Summary

The Erie County Sheriff's Office responded to 209 calls the week of this report. Below is a sampling of the noteworthy incidents in **Grand Island**.

Date	Type	Street	Narrative
01/08	Noxious Odor	Baseline Rd	Complainant reported an extremely strong noxious odor coming from their bathroom. The odor was determined to be paint fumes due a bathroom renovation.
01/08	Motorist Broken Down	Whitehaven Rd @ I 190	Registered Owner reported a wheel fell off their vehicle and rolled away. The owner had a family member fix the vehicle and repair the tire.
01/09	Assist Person	Compass Pass	Deputies were dispatched to check a vehicle parked on the street for five days. Complainant reports seeing 2 males exit the vehicle and leave the street in a different vehicle. Patrol contacted the registered owner who stated they lent their vehicle to their family member who lives and works at the address.

01/14	Accident Hit & Run	Grand Island Blvd.	Complainant states an unknown person struck their vehicle in a parking lot causing minor damage. NY Accident Report completed for the complainant.
01/14	UUMV	Luther Lane	Complainant reports their vehicle stolen overnight. The vehicle was recovered in Buffalo. Detective's conducting an ongoing investigation.
