The Erie County Sheriff's Office responded to 162 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
1/11	Grand Island Blvd.	Suspicious Person with Vehicle	Deputies located a vehicle leaving the Fantasy Island parking lot during the late hours of the night. The driver was determined to be an employee of the business.
1/11	Baseline Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
1/11	Staley Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident involving a telephone pole. No injuries were reported.
1/11	Tracey La.	Flood Condition	Deputies responded to a report of the roadway flooding. The water was determined not to be a hazard.
1/11	Oakridge Rd.	Pistol Permit Investigation	Deputies conducted a background investigation of a subject who applied for a pistol permit.
1/11	East River Rd.	Road Obstruction	Deputies located and removed a pine tree that had blown into the roadway.
1/11	Glen Avon Rd.	Suspicious Vehicle	The complainant states that a suspicious vehicle was driving up and down the roadway numerous times. Deputies checked the area but were unable to locate the vehicle by the description given.
1/11	Homeland Dr.	Suspicious Person with Vehicle	The complainant states that 2 vehicles drove down through the property by the power lines. Deputies located the vehicles which had become stuck in the mud. 2 Juvenile Offenders were arrested for Trespass (Violation) and each issued a number of traffic tickets. The Juvenile Offenders were issued appearance tickets returnable to the Town of Grand Island Court.
1/12	East River Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
1/12	Bedell Rd.	Larceny	The complainant states that sometime in recent hours an unknown subject pried open numerous mailboxes in his apartment complex and stole various items of mail.
1/12	Bedell Rd.	Criminal Contempt	While investigating the above complaint, Deputies arrested 41 y/o Michael Bodell of Grand Island for Criminal Contempt 1 st Degree (Class E Felony) after he was found to be in violation of a Court Order. Bodell was transported to the Erie County Holding Center

			pending his arraignment in the Town of Grand Island Court.
1/12	Red Jacket Rd.	Narcotics Arrest	Following a traffic stop and subsequent investigation, Deputies arrested 23 y/o Brandi Skill of Williamsville, 23 y/o Michael Wienckowski of Grand Island and 22 y/o Brandon Carroll of Grand Island for Criminal Possession of a Controlled Substance 7 th Degree (Class A Misdemeanor). Carroll was additionally charged with Possession of a Hypodermic Instrument (Class A Misdemeanor). All the subjects were issued appearance tickets returnable to the Town of Grand Island Court.
1/12	Bedell Rd.	Animal Complaint	The complainant states that a dog from a neighboring apartment in her complex got loose and attacked her dog. The Dog Control Officer was notified.
1/13	North Colony Rd.	Wires Down	Deputies responded to a report of wires being taken down by a vehicle. National Grid was notified.
1/14	Hennepin Rd.	Larceny	The complainant states that sometime during the night, an unknown person(s) stole various items from her unlocked vehicle.
1/14	South La.	Pistol Permit Investigation	Deputies conducted a background investigation of a subject who applied for a pistol permit.
1/14	Ward Park Rd.	Shots Fired	The complainant states that she heard what appeared to be shotgun blasts in the area. Deputies checked the area and determined the complaint to be unfounded.
1/15	Whitehaven Rd.	Suspicious Incident	The complainant states that 3 subjects were outside and appeared to be smoking pot. Deputies checked the area but were unable to locate any subjects smoking the substance.
1/15	Ransom Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident. One driver was treated on scene with seemingly non-life threatening injuries.
1/15	Bedell Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
1/15	Grand Island Blvd.	Suspicious Person	The complainant states that 2 subjects were acting suspiciously and attempting to sell gift cards to other patrons at Noco. Deputies located the subjects nearby and determined they had committed no criminal act.
1/16	Grand Island Blvd.	Suspicious Person	The complainant states that a female subject wearing dark clothes was walking on Grand Island Blvd carrying a bag. Deputies checked the area but were unable to locate the female by the description given.
1/16	South State Pkwy	Road Obstruction	The complainant states that several large objects were lying in the roadway. Deputies arrived on location to find the owner of the property picking up the items he dropped from a vehicle. The owner was advised.
1/16	Whitehaven Rd.	Reckless Operation	The complainant states that a vehicle was swerving all over the roadway on the I-190 and then exited onto Whitehaven Rd. where the complainant lost sight of the vehicle. Deputies checked the area but were unable to locate the vehicle.
1/17	Bedell Rd.	Suspicious Person	The complainant states that a suspicious subject was looking through his apartment windows at his family inside. The subject fled on foot prior to the arrival of

			Patrol. Deputies checked the area but were unable to locate the subject.
1/17	Ransom Rd.	Reckless Operation	The complainant states that a vehicle was travelling unusually slow down the road way and swerving. Deputies checked the area but were unable to locate the vehicle by the description given.
1/17	I-190	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
