The Erie County Sheriff's Office responded to 144 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
12/26	Grand Island Blvd.	Traffic Complaint	The complainant states that a red colored car was driving recklessly before pulling into NOCO. Deputies located the vehicle parked at the store and advised the driver.
12/26	Love Rd.	Shots Fired	The complainant states he hear numerous shots fired during the late hours of the night. Deputies checked but heard no shots in the area.
12/27	Love Rd.	Fireworks Use	The complainant states that fireworks were being used at a nearby residence during the late hours of the night. Deputies located the residence in question and advised the occupants.
12/27	Whitehaven Rd.	Traffic Complaint	The complainant states that a vehicle was swerving all over the roadway before pulling into TC's Lounge during the late hours of the night. Deputies located the vehicle parked in the lot but it was unoccupied.
12/27	Grand Island Blvd.	Noise Complaint	The complainant states that a neighbor in his motel was playing his TV too loud during the late hours of the night. Deputies checked and determined the complaint was unfounded.
12/27	East River Rd.	Suspicious Incident	The complainant states that 2 subjects were near construction equipment on his property during the late hours of the night. The complainant yelled at the subjects who fled the scene. Deputies checked the area but were unable to locate the subjects. Nothing was reported stolen or damaged.
12/28	West River Rd.	Shots Fired	The complainant states he heard 4 shots coming from the wooded area behind his residence during the late evening hours. Deputies checked but heard no shots.
12/29	Grand Island Blvd.	Suspicious Vehicle	The complainant states that a black SUV was parked in the lot of Family Dollar since yesterday with no one around. Deputies located the vehicle but were unable to contact the registered owner.
12/29	Whitehaven Rd.	Suspicious Person with Vehicle	The complainant states that a pickup truck occupied by 2 male subjects was sitting across the street from his residence for several hours. Deputies located the truck and determined the occupants were completing a

			construction job in the area.
12/29	Blackmon Rd.	Animal Complaint	The complainant states that a dog was outside in the cold for several hours and was concerned for its welfare. The dog was brought inside the residence by the owner prior to the arrival of Patrol. Deputies advised the owner and found the dog to be in good health.
12/30	Staley Rd.	Wires Down	Deputies responded to a report of wires down near the intersection of Baseline Rd.
12/30	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident at the intersection of Baseline Rd. No injuries were reported.
12/31	Baseline Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
12/31	Waterford Pk.	Fireworks Use	The complainant states that a residence on Riverdale Dr. was shooting off fireworks. Deputies checked the area but did not observe any fireworks being used.
12/31	West Park Rd.	Warrant Arrest	Following an investigation of an unrelated complaint, Deputies arrested 29 y/o David McCartney of Grand Island after a check showed he had an outstanding warrant from the Town of Niagara. McCartney was transferred to the custody of the Niagara County Sheriff's Office.
1/1	Stony Point Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
