The Erie County Sheriff's Office responded to 194 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

12/27	Pin Oak Cr.	Warrant Arrest	Deputies arrested 31 y/o Casey Carney of Grand Island on outstanding warrants from the Erie County Sheriff's Office and Buffalo Police Department.
12/27	West River Rd.	Disorderly Person	The complainant states that while he was hunting ducks, a female subject began to harass him and fellow hunters in blinds along the river. Deputies located the female subject and advised her. The hunters did have proper permits to hunt.

Crouse was issued an appearance ticket returnable to the Town of Grand. Island Court.

Sugar was issued an appearance ticket returnable to the Town of Grand.

The driver was transported to a local hospital with seemingly non-life threatening injuries. An investigation of the incident resulted in the arrest of the driver, 44 y/o J.B. Silverthorn of Orchard Park for Driving While Intoxicated and other traffic infractions. Silverthorn refused to submit a sample of his breath for chemical analysis and was issued an appearance ticket returnable to the Town of Grand Island Court.

Deputies spoke with employees on location and learned the complainant wasn't at the business at all during the times in question. Investigation Ongoing.

Lydle registered a .05% B.A.C. after submitting a sample of his breath for chemical analysis. Lydle was transported to the Erie County Holding Center in lieu of \$250 bail.
12/31	East River Rd.	Suspicious Incident	The complainant states that sometime in recent days, an unknown person(s) stole her "For Sale" sign from the front yard. The complainant only wanted to make Patrol aware in case the sign was found.

Traffic Arrest	Following a traffic stop, Deputies arrested 31 y/o Timothy Homa of Grand Island for Aggravated Unlicensed Operation 2 nd Degree (Misdemeanor), Circumventing an Interlock Control Device (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently revoked. Homa was issued an appearance ticket returnable to the Town of Grand Island Court.

Gilchrist was issued an appearance ticket returnable to the Town of Grand Island Court.
12/31	South State Pkwy.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident near the intersection of Love Rd. No injuries were reported.

The vehicle left in an unknown direction prior to the arrival of Patrol. Deputies checked the area but were unable to locate the vehicle by the description given.
