The Erie County Sheriff's Office responded to calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
9/19	Stony Point Rd.	Noise Complaint	The complainant states that a loud party was taking place at a nearby residence during the late hours of the night. Deputies spoke with the occupants and advised them.
9/19	Ransom Rd.	Noise Complaint	The complainant states that a male subject in her apartment complex was revving the engine on his dirt bike during the late hours of the night. Deputies checked the area and determined the complaint was unfounded.
9/19	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
9/19	Brandywine Dr.	ATV Operation	The complainant states that several ATV's and dirt bikes were racing up and down the street. Deputies checked the area but were unable to locate any subjects riding ATV's or dirt bikes.
9/19	Grand Island Blvd.	Animal Complaint	The complainant states that a dog was locked in an unattended vehicle in the parking lot of Tops. Deputies checked but were unable to locate the vehicle by the description given.
9/19	Whitehaven Rd.	Suspicious Vehicle	The complainant states that an occupied vehicle was parked in the street in front of the complainant's residence. Deputies checked and determined the vehicle had broken down and the driver was awaiting the arrival of AAA.
9/19	Whitehaven Rd.	Wires Down	Deputies responded to a report of low hanging wires. Notification was made to the cable company.
9/19	Baseline Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call at a residence on Baseline Rd. Patrol spoke with the occupants and determined they were having problems with their phone line.
9/19	Grand Island Blvd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled due to a flat tire.
9/19	Sandy Beach Rd.	Criminal Mischief	The complainant states sometime in recent hours an unknown person(s) smashed the rear window on his vehicle. Nothing was reported stolen.
9/20	East Park Rd.	Suspicious Incident	The complainant states that a pickup truck was going in and out of all the driveways in the neighborhood.

			Deputies checked the area but were unable to locate the vehicle by the description given.
9/20	Grand Island Blvd.	Burglary	Employees of Brick Over Pizza state that sometime during the night an unknown person(s) entered the business and stole an undetermined amount of money from inside of an office. Investigation Ongoing.
9/20	Baseline Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident near the intersection of Grand Island Blvd. No injuries were reported.
9/20	Love Rd.	Suspicious Person	Deputies located a male subject walking around Kaegabein Elementary School with a flashlight during the late evening hours. The male stated he was looking for some property he lost at the school earlier in the day.
9/20	Ransom Rd.	Disorderly Person	The complainant states that a male subject was revving his motorcycle in the garage of the apartment complex and causing problems with other tenants. Deputies located the male subject and advised him.
9/21	Grand Island Blvd.	Unauthorized Use of a Motor Vehicle	The complainant states that sometime during the night, an unknown person(s) stole a work truck from a business using keys that were found inside of the vehicle. The truck also contained various construction tools. Another vehicle on the lot was also found to be damaged but nothing reported stolen.
9/21	Staley Rd.	Road Rage	The complainant states that the driver of another vehicle was following him and when he pulled into the parking lot the male subject exited his vehicle and confronted the complainant. While attempting to call 911 the male tried to grab the complainant's phone. Deputies located the male subject and their investigation led to the arrest of 56 y/o David Giddings of Grand Island for Harassment 2 nd Degree (Violation). Giddings was issued an appearance ticket returnable to the Town of Grand Island Court.
9/21	Whitehaven Rd.	Suspicious Person	The complainant states that 2 male subjects were walking down the road with backpacks during the late evening hours. Deputies spoke with the subjects who stated they were walking to a nearby business.
9/21	Ransom Rd.	Reckless Endangerment	Deputies and the Grand Island Fire Department responded to a report of a fire alarm at an apartment complex on Ransom Rd. During their investigation they learned that one of the tenants was running a snowmobile in an enclosed garage for an extended period of time causing a large amount of Carbon Dioxide to fill the complex. Deputies arrested 44y/o Scott Hammett of Grand Island for Reckless Endangerment 1 st Degree (Class D Felony). Hammett was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.
9/21	Stony Point Rd.	Driving While Intoxicated	Following a traffic stop, Deputies arrested 61 y/o Richard Kramer of Grand Island for Driving While Intoxicated and other traffic infractions. Kramer registered a .07% B.A.C. after submitting a sample of his breath for chemical. Kramer was issued an appearance

			ticket returnable to the Town of Grand Island Court and released to the custody of a sober 3 rd party.
9/22	West River Rd.	Suspicious Person	The complainant states that a male subject came to her residence claiming to be from the Town of Grand Island and stated there were infractions on her property he needed to inspect. The male left prior to the arrival of patrol after being denied entry by the complainant. Deputies checked the area but were unable to locate the male by the description given.
9/22	Webb Rd.	Suspicious Incident	The complainant states that a neighbor was shooting squirrels and in the process damaged his shed. Deputies spoke with the neighbor and advised him. The complainant did not wish to pursue charges.
9/22	Fix Rd.	Animal Loose	The complainant states that a dog was running loose in the neighborhood. The Dog Control Officer was notified.
9/23	East River Rd.	Noise Complaint	The complainant states that workers next door were playing their music too loud. Deputies spoke with all parties and advised them.
9/23	West River Rd.	Robbery	The complainants states that a male subject came to their door claiming to be from the Town of Grand Island and stated he needed to inspect infractions on the property. After being let inside, the male subject hit one of the complainants over the head with a weapon and stated he was there to rob them. The female complainant was able to get to a neighbor's residence and call 911. The subject fled in a white vehicle shortly after and was last seen headed southbound on West River Rd. Investigation Ongoing.
9/23	East River Rd.	Suspicious Person with Vehicle	The complainant states that several vehicles were parked in the lot of his apartment complex and numerous subjects were hanging around that did not belong there. Deputies checked the area and determined the complaint to be unfounded.
9/24	Staley Rd.	Larceny	The complainant states that sometime in recent days, an unknown person(s) stole the license plates from her vehicle.
9/24	Whitehaven Rd.	Larceny	The complainant states that while his car was parked at Byblos Niagara Resort & Spa an unknown person(s) stole various items from inside.
9/24	Love Rd.	Suspicious Vehicle	The complainant states that a white van was acting suspiciously and then parked nearby. Deputies located the vehicle but found no indications of suspicious activity.
9/24	Grand Island Blvd.	Suspicious Person with Vehicle	The complainant states that an occupied vehicle was parked in the back of the Fantasy Island Parking lot during the late evening hours. Deputies located the vehicle and advised the occupants.
9/24	West River Rd.	Suspicious Vehicle	Deputies located a suspicious vehicle parked on West River Rd. during the late hours of the night. The driver was located nearby and advised.
9/24	Baseline Rd.	Suspicious Vehicle	The complainant states that a vehicle was parked near East River Rd. and the rear doors were open. Deputies

			checked the area but were unable to locate the vehicle by the description given.
9/25	Woodstream Dr.	Suspicious Vehicle	The complainant states that a male subject was unloading boxes from a white van into a nearby residence. Deputies located the vehicle and spoke with the driver who was completing work on the house.
9/25	Sandy Beach Rd.	Suspicious Vehicle	The complainant states that a white van was going door to door on Sandy Beach Rd. Deputies checked the area but were unable to locate the vehicle by the description given.
9/25	Baseline Rd.	Suspicious Vehicle	The complainant states that a white van drove by the intersection of Bedell Rd. numerous times. Deputies checked the area but were unable to locate the vehicle by the description given.
