



## Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 154 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
9/29	Sandy Beach Rd.	Barking Dog	Complainant states that a dog was barking for a few hours late at night. Deputies located the dog and contacted the owners. The owners brought the dog inside.
9/29	Ward Park Rd.	Loud Music	Complainant states that a loud party was at a residence in the neighborhood. Deputies located the residence and advised the subjects.
9/29	Grand Island Blvd.	Suspicious Vehicle	Employee at Noco states that a suspicious van was parked in the lot for a long period of time. The vehicle left prior to the arrival of Patrol.
9/29	Deerwood La.	Larceny	Complainant states that sometime during the night an unknown person(s) stole cans of paint from his front porch.
9/29	Baseline Rd.	Deer Struck	Complainant states that a deer appeared to be injured from being struck by a vehicle.
9/29	Center Terr.	Suspicious Person	Security at Town Hall Terrace Apartments found a man sleeping on the porch. Deputies assisted the man back to his residence.
9/29	Love Rd.	Warrant Arrest	Deputies arrested 54 y/o Linda Bruce of Grand Island on a Bench Warrant issued from the Town of Grand Island Court. Bruce was transported to the Erie County Holding Center.
9/29	Fix Rd.	Fireworks Use	Complainant states that a residence in the neighborhood was using fireworks. Deputies checked the area but were unable to locate any subjects.
9/29	Grand Island Blvd.	Suspicious Person	Complainant states that a male subject was lying in front of his vehicle in the Fantasy Island parking lot. Deputies checked the area but were unable to locate the vehicle.
9/29	Grand Island Blvd.	Warrant Arrest	Deputies arrested 56 y/o Kelly Giglia of Grand Island on a Bench Warrant issued from the Town of Grand Island Court. Bruce was transported to the Erie County Holding Center.
9/29	Huth Rd.	Animal Loose	Complainant states that a large dog was running loose in the area. Prior to the arrival of Patrol, the dog returned to his residence.

9/29	East River Rd.	Suspicious Vehicle	Complainant states that a suspicious vehicle was parked in a neighboring driveway and did not belong there. Deputies were able to locate the owner who was at a party next door.
9/29	South State Pkwy	Reckless Operation	Complainant states that a vehicle was travelling the wrong direction on South State Pkwy. Deputies checked the area but were unable to locate the vehicle.
9/29	East River Rd.	Suspicious Incident	Complainant states that the driver of a red minivan threw a beer can out his window, and struck the complainants vehicle. Deputies checked the area but were unable to locate the vehicle.
9/30	Oakridge Dr.	Youth Activity	Complainant states that some youths were knocking on doors and running during the late hours of the night. Deputies checked the area but were unable to locate the youths.
9/30	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
9/30	Baseline Rd.	Disorderly Person	Complainant states that 2 males were in his yard arguing during the late evening hours. Deputies located the male subjects. Their subsequent investigation led to the arrest of 25 y/o Travis Stevens of Cortland NY for Disorderly Conduct (a Violation), Criminal Mischief 4 <sup>th</sup> Degree (Class A Misdemeanor), Resisting Arrest (Class A Misdemeanor) and Obstruction of Governmental Administration 2 <sup>nd</sup> Degree (Class A Misdemeanor). Stevens was issued an appearance ticket returnable to the Town of Grand Island Court.
9/30	Bedell Rd.	Suspicious Vehicle	Complainant states that a suspicious van was parked in the Country Glen Apartments parking lot. Deputies checked but located no suspicious van.
10/1	Love Rd.	Larceny	Employee at Sunoco states that a subject drove off without paying for gasoline. The subject returned to the gas station and paid for the fuel.
10/1	East River Rd.	Animal Bite	Complainant states that she was bitten by a dog on East River Rd. The Dog Control Officer was notified.
10/1	Whitehaven Rd.	Traffic Control Device	Deputies responded to a report of the traffic signal at Whitehaven Rd. and Baseline Rd. flashing red in all directions. Grand Island Highway Department was notified.
10/2	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
10/2	Staley Rd.	Larcenies	Several neighbors stating that sometime during the night, an unknown person(s) stole various items from their unlocked vehicles. Investigation Ongoing.
10/2	Carl Rd.	Youth Activity	Complainant states that several suspicious youths were hanging out at the Carl Rd. playground. Deputies located the subjects and advised them. The subjects left without incident. No damage was observed.
10/2	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
10/3	Love Rd.	Loud Music	Complainant states that loud music was coming from Say Cheese Pizza late at night. Deputies advised the employees.

10/3	Fix Rd.	Suspicious Vehicle	Complainant states that a suspicious vehicle was parked in the street and a few subjects were seen going to and from the vehicle. Deputies located the vehicle in question but observed no subjects. The vehicle was ticketed and towed for parking violations.
10/3	Fix Rd.	Narcotics	Complainant states that he found a bag of marijuana and an unidentified narcotic in his driveway. The drugs were turned over to Patrol for destruction.
10/3	Baseline Rd.	Pistol Permit Investigation	Deputies conducted a background check of an individual who applied for a pistol permit.
10/3	Bedell Rd.	Suspicious Person	Complainant states that a suspicious male was walking around inside of a storage yard. Deputies located the male and advised him.
10/4	East Park Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call on East Park Rd. Deputies determined the call to be accidental.
10/4	Grand Island Blvd.	Possession of Marijuana	Following an investigation of a suspicious person complaint, Deputies arrested a juvenile offender for Unlawful Possession of Marijuana. The juvenile offender was issued an appearance ticket returnable to the Town of Grand Island Court.
10/5	Stony Point Rd.	Traffic Arrest	Following a traffic stop, Deputies arrested 32 y/o Monique Kramer for Aggravated Unlicensed Operation 3 <sup>rd</sup> Degree after a DMV check showed her license was currently suspended. Kramer was issued an appearance ticket returnable to the Town of Grand Island Court.
10/5	Bedell Rd.	Refer to Patrol	Complainant states that a large crane was operating on Bedell Rd. in front of Veterans Park and making a lot of noise. The complainant was advised that the crane was making improvements to the road.
