The Erie County Sheriff's Office responded to 177 calls the week of this report. Below is a sampling of the noteworthy incidents on **<u>Grand Island</u>**.

10/5	East River Rd.	Loud Music	The complainant states that loud music was coming from a nearby residence during the late hours of the night. Deputies located the house and advised the occupants.
10/5	Colonial Dr.	Flood Condition	Deputies responded to a report of flood conditions in the roadway. NITTEC was notified.
10/5	East Park Rd.	Flood Condition	Deputies responded to a report of flood conditions in the roadway. NITTEC was notified.

10/8	Broadway	Open Door	The complainant states she arrived at a property she owns and found an open door. She further stated no one should be inside the home. Deputies checked and found no subjects inside.
10/8	Ferry Rd.	Suspicious Person	The complainant states that several subjects were walking through the yards. Deputies located the subjects who were delivering phone books in the area.

Traffic Arrest/Narcotics Arrest	Following a traffic stop and subsequent investigation Deputies arrested 33 y/o Justin Gaesser of Cheektowaga for traffic infractions and Aggravated Unlicensed Operation 3 rd Degree after a DMV check confirmed Gaesser's license was suspended. Gaesser was also found to be in possession of suspected Heroin and a hypodermic needle and was further charged with Criminal Possession of a Controlled Substance 7 th Degree (Class A Misdemeanor) and Possession of a Hypodermic Instrument (Class A Misdemeanor). Gaesser was transported to the Erie County Holding Center and was also found to have a Warrant from the City of Buffalo.
10/9	Love Rd.	Accident Hit & Run	The complainant states sometime yesterday an unknown vehicle struck his parked car and then left the area. No injuries were reported.
10/9	Whitehaven Rd.	Animal Loose	The complainant states a dog was running loose in the neighborhood. The Dog Control Officer was notified.
10/9	Grand Island Blvd.	Warrant Arrest	Following an investigation of an unrelated complaint, Deputies arrested 28 y/o Kaitlin Isabella of Schenectady NY after she was found to have an outstanding Arrest Warrant from the City of Buffalo. Isabella was transferred to the custody of the Buffalo Police Department.
10/9	Harvey Rd.	Suspicious Vehicle	The complainant states that a suspicious vehicle was parked on the side of the road. Deputies located the driver who was hiking in the woods and advised him.
10/9	Baseline Rd.	Warrant Arrest	Deputies arrested 41 y/o William Boaz of West Seneca after he turned himself in on Bench Warrant from Grand Island Town Court. Boaz was transported to the Erie County Holding Center.
10/9	Whitehaven Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident involving a motorcyclist. The motorcyclist was transported to a local hospital with seemingly non-life threatening injuries.
10/10	Whitehaven Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.

10/10	Grand Island Blvd.	Reckless Operation	The complainant states a vehicle was driving recklessly down the roadway. Deputies checked the area but were unable to locate the vehicle by the description given.
10/10	Baseline Rd.	Suspicious Incident	The complainant states that she found a bag of a white powder substance and did not know what it was. Deputies tested the substance but it was negative for any narcotic drug.
10/10	Alvin Rd.	Larceny	The complainant states that sometime in the recent days, an unknown person(s) stole various items from his vehicle while it was parked at Fucillo Chevrolet.

10/11	Love Rd.	Larceny	The complainant states that approximately 1 month ago her purse was stolen by an unknown person(s) while she was at Say Cheese Pizza.
10/11	Wallace Dr.	Parking Violation	The complainant states that a vehicle was partially blocking her driveway. The vehicle left prior to the arrival of Patrol.
10/11	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 4 car motor vehicle accident. No injuries were reported.

Traffic Arrest	Following a report of a reckless operation and subsequent investigation, Deputies arrested 47 y/o David Wylke of Grand Island for Aggravated Unlicensed Operation 3 rd Degree, Possession of Hypodermic Instrument (Class A Misdemeanor), and Drinking Alcohol in a motor vehicle. Wylke was issued an appearance ticket returnable to the Town of Grand Island Court.
