



Erie County Sheriffs Office Media Release Summary

Dates: 10/6/2012 to 10/12/2012

The Erie County Sheriff's Office responded to 155 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
10/6	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
10/6	Bedell Rd.	Parking Violation	Complainant states that a vehicle was blocking a handicap spot in the Country Glen Apartments. Deputies issued a parking ticket.
10/6	Center Terr.	Suspicious Vehicle	Complainant states that a suspicious vehicle was parked in the roadway and appeared to be occupied. Deputies located the vehicle, whose driver pulled over to use her cellular phone.
10/6	Fix Rd.	Suspicious Incident	Complainant states that he heard a loud banging in the area of Fix Rd. and Baseline Rd. Deputies checked but did not hear any loud banging.

10/7	Ward Park Rd.	Youth Activity	Complainant states that 2 youths were running through backyards in the area. Deputies checked but were unable to locate the youths.
10/7	Marilyn Dr.	Suspicious Incident	Complainant states that he observed 2 youths throw an object at a residence. Deputies located the 2 youths who were advised and turned over to their parents.

10/8	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 3 car motor vehicle accident. No injuries were reported.
10/8	Stony Point Rd.	Larceny	Complainant states that sometime during recent weeks,

			an unknown person(s) stole a tree stand from his property.
10/8	Ransom Rd.	Suspicious Person	Complainant states that a suspicious male was walking around the parking lot of her apartment complex. Deputies checked the area but were unable to locate the subject.
10/8	Whitehaven Rd.	Customer Trouble	Employee of NOCO states that an intoxicated male entered the store and attempted to buy beer. The employee refused to sell the subject the alcohol, and the male caused a disturbance. The subject left on foot prior to the arrival of Patrol. Deputies checked the area but were unable to locate the subject.
10/9	Winkler Dr.	Pistol Permit Investigation	Deputies conducted a background check of an individual who applied for a pistol permit.
10/9	Baseline Rd.	Suspicious Person	Complainant states an elderly male was walking down the road and appeared to be lost. Deputies located the subject and assisted him in getting home.
10/9	Marilyn Dr.	Larceny	Complainant states that fraudulent charges were made on his credit card. Investigation Ongoing.
10/9	Woodlee La.	Suspicious Incident	Complainant states a screen window was damaged in an apparent attempt to enter her residence. No entry was made.
10/9	Marilyn Dr.	Residential Burglary	Complainant states that sometime during the day, an unknown person(s) entered his residence through an unlocked door and stole various items. Investigation Ongoing.
10/9	Whitehaven Rd.	Larceny	Complainant states that sometime in recent days, an unknown person(s) stole various landscaping items from a cemetery on Whitehaven Rd.
10/9	Baseline Rd.	Welfare Check	Deputies responded to a 911 hang up call. Deputies spoke to the occupants and determined the call to be an accident.
10/9	Bedell Rd.	Parking Violation	Complainant states that a vehicle was blocking a handicap spot in the Country Glen Apartments. Deputies issued a parking ticket.
10/10	Carter Dr.	Assist Person	Complainant states that a construction company was operating noisy equipment in the early hours of the morning. Deputies advised all parties.
10/10	West River Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
10/10	Staley Rd.	Larceny	Complainant states that an unknown person(s) stole a manhole cover from the street. Investigation Ongoing.
10/10	Love Rd.	Accident Injury	Deputies responded to a report of a bicyclist struck by a vehicle on Love Rd. The bicyclist was transported to a local hospital with seemingly non-life threatening injuries.
10/10	East River Rd.	Suspicious Incident	Complainant states that earlier in the day, 2 men came to her house and claimed they were working for the state and needed to do measurements. The complainant told the men to come back which they never did.
10/10	East River Rd.	Animal Loose	Complainant states that a loose dog was running through the neighborhood. Deputies located the dog and returned it to the owner.

10/11	Grand Island Blvd.	Larceny	Employees of Dunkin Donuts stated that another employee stole money from the business. Deputies investigation led to the arrest of 28 y/o Ryan McDonough of Grand Island for Petit Larceny (Class A Misdemeanor). McDonough was issued an appearance ticket returnable to the Town of Grand Island Court.
10/11	East River Rd.	Larceny	Complainant states that during recent weeks, a known person stole cash from her residence. Investigation Ongoing.
10/11	Jen Ct.	Suspicious Incident	Complainant states that 3 suspicious males came to her residence and attempted to sell raffle tickets for an inner city football program. The complainant was concerned the subjects were scoping out the neighborhood. Deputies checked the area but were unable to locate the subjects.
10/12	Woodlee La.	Suspicious Person	Complainant states that earlier in the morning a suspicious male subject walked through his backyard. Deputies checked the area but were unable to locate any subjects.
10/12	Bedell Rd.	Wire Down	Deputies responded to a report of a wire down on Bedell Rd. National Grid was notified.
10/12	Wallace Dr.	Suspicious Person	Complainant states a suspicious male subject came to her residence to sell raffle tickets for an inner city football program. Deputies located the male a short distance away and advised him.
10/12	Grand Island Blvd.	Accident Hit & Run	Deputies responded to a report of a 2 car motor vehicle accident in a parking lot on Grand Island Blvd. The complainant stated that a vehicle struck another vehicle in the lot and then left the scene. Deputies located the suspect vehicle and arrested the driver 23 y/o Justin Szykowny of Grand Island for Aggravated Unlicensed Operation 3 rd Degree and other vehicle and traffic violations.
10/12	Grand Island Blvd.	Warrant Arrest	Following an investigation of an accident hit & run, Deputies arrested 23 y/o Justin Szykowny of Grand Island, after a check showed Szykowny had an outstanding Arrest Warrant from the Town of Cheektowaga. Szykowny was turned over to the Cheektowaga Police Department.
10/12	Woodlee La.	Residential Burglary	Complainant states that sometime during the previous night, a known person(s) entered his residence by breaking a 2 nd floor window. Investigation Ongoing.
