The Erie County Sheriff's Office responded to 251 calls the week of this report. Below is a sampling of the noteworthy incidents in **Grand Island**.

Date	Type	Street	Narrative
10/10	UUMV	Stony Point Rd.	Deputies received a complaint from a resident who says his work truck was stolen overnight. Vehicle was entered into the database as stolen and forwarded to the detective bureau.
10/10	Traffic Stop/ Arrest	I-190 @ Long Rd.	Deputies initiated a traffic stop on a black Chrysler sedan. The vehicle was found to be suspended for insurance reasons. The driver/owner was found to also have a suspended license. Suspect was arrested for those charges and released on UTT's. The vehicle was towed and the plates were confiscated.
10/11	Traffic Stop/ Warrant Arrest	I-190 @ Whitehaven Rd.	Deputies initiated a traffic stop on a red Toyota sedan. The driver was identified and found to have 8 outstanding warrants out of the City of Buffalo. He was detained and turned over to Buffalo PD.
10/11	Motorcycle Complaint/ AUO	Grand Island Bd. @ Bedell Rd.	Deputies responded to a traffic complaint of motorcycle's speeding in the area. Deputies located several motorcycle's unoccupied at a residence near the corner. Shortly later one motorcycle was located at a high rate of speed on the I-190S. Deputies acquired the plate number and the driver, was later located and charged with several misdemeanor charges. He was taken to the ECHC because of an active warrant as well.
10/14	Youth Activity	Bruce Lane	Deputies responded to children in the neighborhood banging on doors. Deputies located a 10 and 8 year old apparent siblings and returned them to their parents on Carter Dr. All parties were advised.
10/15	ATV Operation on Street	West River Rd @ Sunset Dr.	Deputies received complaints of dirt bikes riding down the roadway along West River Rd. Witnesses said the bikes pulled into a residence on Alt Blvd. Deputies located one bike and had it towed. No one was answering at the residence. Shortly later another bike showed up so they towed that one as well. Property owner finally returned was very agitated with patrol being on his property. He was advised of the situation and Deputies cleared the scene.
10/16	Mental	Towerwood Rd.	Deputies responded to a male possibly overdosing on pills while video chatting. Deputies arrived to find that the male had left on foot. Due to the circumstances the subject's phone was pinged to find his location. Subject was later found on the side of the road cold and disturbed. Subject was transported to ECMC on MHL 9.41 papers for evaluation.
