

## **Erie County Sheriffs Office Media Release Summary**

The Erie County Sheriff's Office responded to 191 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Туре	Narrative
10/10	East Park Rd.	Suspicious Vehicle	The complainant states that a vehicle was parked on the front lawn of a neighbor's residence and did not belong there. Deputies located the driver nearby who was working on paving the roadway. The driver returned to the vehicle and moved it.
10/10	Stony Point Rd.	Suspicious Incident	The complainant states that she found a glass smoking device on her front lawn and wanted to turn it over to Patrol. Deputies took the item and discarded it.
10/10	Ransom Rd.	Suspicious Incident	The complainant states that 4 syringes were lying along the roadway by the Grand Island Market. Deputies secured the items and disposed of them.
10/10	East Park Rd.	Road Rage	The complainant states he was followed to his residence by another driver after a road rage incident. Deputies located the other driver nearby. All parties were advised.
10/10	Alvin Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle became disabled.
10/10	Grand Island Blvd.	Suspicious Incident	Employees of Just Pizza state they received a phone threat from a customer who was upset that his pizza was cut into slices instead of squares. Deputies were unable to make contact with the customer at his residence.
10/11	Love Rd.	Drunk Driving	Following Patrol's investigation of an unrelated complaint, Deputies arrested 34 y/o Seadra Ponvert of Grand Island for Driving While Intoxicated and other traffic infractions. Ponvert registered a .14% B.A.C. after submitting a sample of his breath for chemical analysis. Ponvert was issued an appearance ticket returnable to the Town of Grand Island Court.
10/11	Grand Island Blvd.	Barking Dog	The complainant states that a dog was barking for several hours in a nearby apartment. Deputies spoke with the occupants and advised them.
10/11	Bush Rd.	Suspicious Incident	Deputies found a speed limit sign on Bush Rd. that an unknown person(s) had used electrical tape to change the speed limit to 85 mph. Deputies removed the tape.

10/11	Grand Island Blvd.	Open Door	A customer picking up his vehicle at Monroe Muffler found that the door to the business was open and no employees were around. Deputies checked the business and found no person or signs of disturbance inside. A key holder responded to the business and locked the building.
10/11	Love Rd.	Suspicious Incident	The complainant states that 2 youths were smoking marijuana on the basketball courts. Deputies checked and found the complaint to be unfounded.
10/11	Staley Rd.	ATV Operation	The complainant states that ATV's were ripping up and down the street during the late evening hours. Deputies located 1 driver and advised him.
10/12	South La.	Suspicious Vehicle	The complainant states she observed a male subject sitting in a white van near the bike path. The vehicle left the area prior to the arrival of patrol. Deputies checked but were unable to locate the vehicle by the description given.
10/12	East River Rd.	Animal Complaint	The complainant states that a pickup truck was driving down the road and had 3 dogs in the bed of the truck.  Deputies located the vehicle parked at a nearby residence and advised the driver.
10/12	East River Rd.	Barking Dog	The complainant states that a dog was barking on the deck of Turners Port of Call f or several hours. Deputies were able to make contact with the owner and advised him.
10/12	Whitehaven Rd.	Traffic Complaint	The complainant states that a vehicle was swerving down the road and the driver seemed to be drinking a beer. Deputies checked the area but were unable to locate the vehicle by the description given.
10/13	Gregory Pl.	Animal Bite	The complainant states that a neighbor's dog was running loose and bit him. The Dog Control Officer was notified.
10/13	Stony Point Rd.	Fireworks Use	The complainant states that a neighbor was shooting fireworks during the previous few nights.
10/13	East River Rd.	Road Obstruction	The complainant states that a construction company was completing work in the area and their vehicles were blocking traffic. Deputies spoke with the employees and advised them.
10/14	Baseline Rd.	Suspicious Incident	The complainant states that an unknown person(s) was walking around her residence during the late hours of the night. Deputies checked but found no persons in the area.
10/14	Whitehaven Rd.	Youth Activity	The complainant states that several youths were behind a church during the late hours of the night and took off when they saw the complainant. Deputies checked the area but found no youths.
10/14	South State Pkwy.	Traffic Arrest	Following a traffic stop, Deputies arrested 22 y/o Kayla Fix of North Tonawanda for Operating a Motor Vehicle with a Suspended Registration (Misdemeanor) and other traffic infractions after a DMV check showed her registration was suspended. Fix was issued an appearance ticket returnable to the Town of Grand Island Court.

10/14	Grand Island Blvd.	Suspicious Person with Vehicle	Employees of Family Dollar state that a male subject was sitting in a pickup truck outside of business during the late hours of the night. The truck left prior to the arrival of Patrol. Deputies checked the area but were unable to locate the vehicle by the description given.
10/15	Grand Island Blvd.	Burglary	Employees of Island Pets & Feed state that sometime during the night, an unknown person(s) broke into the store by smashing a window and stole numerous things from inside. The Erie County Sheriff's Office Crime Scene Unit responded for evidence collection.  Investigation Ongoing.
10/15	Cardinal La.	Burglary	The complainant states that she caught 2 youths in her garage. 1 youth fled the scene prior to the arrival of Patrol but was located nearby. Deputies investigation revealed the youths had entered several garages in the area stole several bicycles from them. The bicycles were returned to the proper owners. Because of their age the 2 Juvenile Offenders were petitioned to Grand Island Youth Court on a future date for charges including Burglary, Larceny and Criminal Trespass.
10/15	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident near the intersection of Baseline Rd. No injuries were reported.
10/15	Grand Island Blvd.	Suspicious Person	Deputies located a subject walking around the First Niagara Bank during the late hours of the night. The subject was advised and left without incident.
10/16	Bedell Rd.	Animal Bite	The complainant states that a male subject was being attacked by a pit bull in the complex of the Country Glen Apartments. Deputies located the male subject who was not injured in the incident. The Dog Control Officer was notified.
10/16	Fix Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
10/16	White Tail Run	Suspicious Person	The complainant states that a male subject came to a neighbor's house, entered the garage and stated he could walk right in during the late hours of the night. When the neighbor's dog began to bark the subject left the area in an unknown direction. The neighbor then reported the incident to the complainant who called 911. The complainant refused to give any other information on an address of occurrence or his name. Deputies checked the area but with the minimal information provided were unable to locate the subject.

Deputies responded to 18 Burglary False alarm calls and 4 Fire Alarms during the dates of this report.
