



Erie County Sheriffs Office Media Release Summary

Dates: 10/13/2012 to 10/19/2012

The Erie County Sheriff's Office responded to 163 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
10/13	I-190	Drunk Driving	While on Patrol, Deputies observed a vehicle travelling southbound in the northbound lanes on the I-190. Deputies initiated a traffic stop and their subsequent investigation led to the arrest of 23 y/o Jessica Lemmon of Amherst for Driving While Intoxicated and other traffic infractions. Lemmon registered a .17% B.A.C. after submitting a sample of her breath for chemical analysis. Lemmon was issued an appearance ticket returnable to Town of Grand Island Court and released to a sober 3 rd party.
10/13	Jenell Dr.	Animal Loose	Complainant states a large dog was running loose in the area. The Dog Control Officer was notified.
10/13	Baseline Rd.	Parking Violation	Complainant states that several vehicles were parked illegally in a private business lot. Deputies located the owners of the cars, who moved the vehicles.
10/13	Waterford Pk.	Loud Music	Complainant states that loud music was being played from a residence in the neighborhood. Deputies located the source of the music and advised the homeowner.
10/13	Ransom Rd.	Animal Complaint	Complainant states that a unknown animal was in her house and was growling. The Dog Control Officer was notified.
10/14	East River Rd.	Harassment	Complainant states he was receiving harassing phone calls from a known person. Investigation Ongoing.
10/14	Grand Island Blvd.	Suspicious Person	Complainant states a suspicious subject was panhandling in front of Dollar Tree. Deputies located the subject and advised him.
10/14	Whitehaven Rd.	Reckless Operation	Complainant states that a vehicle was driving fast through an apartment complex. Deputies checked the area but were unable to locate the vehicle.
10/14	Fernwood La.	ATV Operation	Complainant states that 2 dirt bikes were riding down the street. Deputies checked the area but were unable to locate the dirt bikes.
10/14	Grand Island Blvd.	Larceny	Complainant states that sometime in recent days, an unknown person(s) stole a boat from a trailer on his property.

10/14	Staley Rd.	Animal Injury	Complainant states that an injured possum was in the roadway. Deputies removed the animal from the road.
10/14	Deerwood La.	Attempted Break In	Complainant states that the sliding door to her residence had been damaged in an attempt to enter the home. No entry was made.
10/14	Carl Rd.	Disturbance	Complainant states she heard loud yelling coming from the street, then observed 2 subjects fighting. Deputies located the subjects who admitted to having a disagreement. The subjects were advised.
10/14	Baseline Rd.	Property Found	Complainant states that a bicycle was found abandoned in the ditch. Deputies transported the bicycle back to the Grand Island Substation to be claimed.
10/14	I-190	Reckless Operation	Deputies responded to a report of a vehicle operating recklessly on the I-190. Deputies checked the area but were unable to locate the vehicle.
10/14	Grand Island Blvd.	Burglary	Deputies responded to a report of an alarm ringing at a commercial business. Upon arrival, Deputies found a rear window to the business smashed. No suspects were observed in the area and nothing was reported missing at the time of the report. Investigation Ongoing.
10/15	Grand Island Blvd.	Burglary	Complainant states that sometime during the night, an unknown person(s) broke into his business by smashing a window and stole various items. Investigation Ongoing.
10/15	Baseline Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants and determined the call to be a misdial.
10/15	Evelyn Ct.	Suspicious Incident	Complainant states that a suspicious vehicle followed him to his home. The complainant was able to get the license plate of the vehicle before it fled the scene. Deputies spoke to the owner of the suspect vehicle and advised him.
10/15	Buckhorn Ct.	Harassment	Complainant states she was receiving harassing phone calls from a blocked number.
10/15	West River Pkwy	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
10/16	Grand Island Blvd	Larceny	Complainant states that sometime in recent days, an unknown person(s) stole various tools from a trailer parked in a business lot. Investigation Ongoing.
10/16	Fix Rd.	Suspicious Vehicle	Complainant states a suspicious vehicle was parked on the street and seemed to be occupied. Deputies checked the area but were unable to locate the vehicle.
10/16	Grand Island Blvd.	Assist Person	Complainant stated that his wallet was stolen approximately a day before the time of the report. The wallet was located and returned to the owner.
10/16	Enola Rd.	Suspicious Vehicle	Complainant states a suspicious vehicle was parked in the street and had multiple occupants inside. Deputies located the vehicle a short distance away and advised the subjects.
10/16	Revere Rd.	Residential Burglary	Complainant states that sometime during the day, an unknown person(s) entered her home through an unlocked door and stole various items. Investigation Ongoing.

10/16	Stony Point Rd.	Pistol Permit Investigation	Deputies conducted a background check of an individual who applied for a pistol permit.
10/16	Grand Island Blvd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
10/17	Grand Island Blvd.	Criminal Mischief	Complainant states that sometime during the night, an unknown person(s) punched a hole in the gas tank of her vehicle and syphoned out fuel.
10/17	Baseline Rd.	Suspicious Incident	Complainant states she heard a loud explosion or possibly a gun shot in the area. Deputies checked the area but did not hear any other loud noises.
10/17	Staley Rd.	Accident Hit & Run	Deputies responded to a report of a 2 car motor vehicle accident, where one driver fled the scene. Deputies were unable to locate the vehicle that fled. No injuries were reported.
10/17	Grand Island Blvd.	Disturbance Public Place	Complainant states that several subjects were inside of McDonalds Restaurant and were being loud and using vulgar language. Deputies were unable to locate the subjects, and spoke to employees who reported no such problem.
10/18	Marjorie Drive	Barking Dog	Complainant states 2 dogs in the neighborhood were constantly barking during the late hours of the night. Deputies checked the area but were unable to locate any barking dogs.
10/18	Fareway La.	Residential Burglary	Complainant states that sometime during the day, a known person entered her residence and stole various items from inside. Investigation Ongoing.
10/18	Baseline Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants who were having service work done to their home.
10/18	East Park Rd.	Wire Down	Deputies responded to a report of a wire down and arcing on a tree. National Grid was notified.
10/19	Jamestown Rd.	Pistol Permit Investigation	Deputies conducted a background check of an individual who applied for a pistol permit.
10/19	Grand Island Blvd.	Larceny	Complainant states that sometime in recent days, an unknown person(s) stole a truck and a forklift from Fantasy Island. Investigation Ongoing.
10/19	East Oakfield Rd.	Shots Fired	Complainant states he heard multiple shots fired in the area. Deputies checked the area but were unable to locate any source of gun shots.
