



## Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 180 calls the week of this report. Below is a sampling of the noteworthy incidents on Grand Island.

9/26	Huth Rd.	Drunk Driving	Following a traffic stop, Deputies arrested 23 y/o Kevin O'Brien of Grand Island for Driving While Intoxicated, Unlawful Possession of Marijuana (Violation) and other traffic infractions. O'Brien registered a .19% B.A.C. after submitting a sample of his breath for chemical analysis and was further charged with Aggravated Driving While Intoxicated due to the elevated reading. O'Brien was issued an appearance ticket returnable to the Town of Grand Island Court and released to the custody of a sober 3 <sup>rd</sup> party.
9/26	Ransom Rd.	Larceny	The complainant states that sometime in the past hour an unknown person(s) stole a large pump from his yard. The pump was found a day later by a neighbor and returned to the complainant.
9/26	Baseline Rd.	Traffic Complaint	The complainant states that the driver of another vehicle slammed on his brake abruptly then gave the complainant the middle finger. Deputies located the vehicle and advised the driver.
9/26	East River Rd.	Traffic Complaint	The complainant states that several cars and a motorcycle routinely travel at a high rate of speed down the road.
9/26	Bedell Rd.	Suspicious Person with Vehicle	Deputies located a subject sleeping in a vehicle in Veterans Park. The subject stated his residence was being fumigated and he didn't have anywhere else to go.
9/26	Brandywine Dr.	Suspicious Vehicle	The complainant states that a white van was parked at a nearby residence and the driver got out of the van and went to the door. Deputies spoke with the driver who was delivering carpets to the house.
9/26	Hennepin Rd.	Animal Complaint	The complainant states that a raccoon was in the yard and looked to be in distress.
9/26	Baseline Rd.	Suspicious Person with Vehicle	Deputies located a vehicle parked near the pipeline and the driver inside was looking through binoculars. The driver stated he was scouting deer for the upcoming hunting season.
9/28	Whitehaven Rd.	Larceny	The complainant states that while he was a guest at

			Byblos Niagara Resort & Spa an unknown person(s) stole his wallet.
9/28	Stony Point Rd.	Stony Point Rd.	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
9/28	Jamestown Rd.	Criminal Mischief	The complainant states that sometime during the night an unknown person(s) knocked down her mailbox.
9/28	Grand Island Blvd.	Suspicious Person	The complainant states that a male subject in front of Fantasy Island was walking in and out of traffic. Deputies located the male who was waiting for the bus and advised him.
9/28	Sturbridge La.	Youth Activity	The complainant states that a group of youths were walking around the property of a vacant residence. Deputies located the youths and advised them.
9/28	Ransom Rd.	Suspicious Incident	The complainant states that the dome light was on in her vehicle during the late hours of the night and was concerned someone was inside. Deputies checked but found no persons or signs of disturbance inside the vehicle.
9/28	Love Rd.	Animal Loose	The complainant states that he found 2 dogs running loose in the area. The Dog Control Officer was notified.
9/28	Baseline Rd.	Suspicious Person	Deputies located a male subject walking in the roadway during the late hours of the night. The subject was advised.
9/28	Whitehaven Rd.	Larceny	The complainant states that while she was at Byblos Niagara Resort & Spa an unknown person(s) stole her laptop from the lobby. Deputies reviewed the surveillance tapes from the hotel and determined no property was stolen.
9/28	East River Rd.	Suspicious Incident	The complainant states that his car alarm started going off during the late hours of the night but did not see anyone around. Deputies checked but found no persons in the area or signs of a disturbance in the vehicle.
9/29	Sheree Dr.	Welfare Check	Deputies responded to a report of a 911 hang up call at a residence. Deputies spoke with the occupants and determined the call was a misdial.
9/29	West River Rd.	Suspicious Person	Several complainants state that a male subject was repeatedly knocking on their door during the early morning hours. One complainant identified the male subject as a neighbor. Deputies checked the area but were unable to locate the male.
9/29	Baseline Rd.	Suspicious Person	The complainant states that a male subject was walking around the garage of a neighboring residence and did not belong there. Deputies checked the area but were unable to locate the subject. The residence was secure and no damage was observed.
9/29	West River Rd.	Larceny	The complainant states that sometime in recent hours an unknown person(s) stole the license plates from his vehicle. Deputies located a subject in the area who had taken the license plates. The plates were returned to the owner who did not wish to pursue charges.
9/29	Baseline Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call at a residence. Deputies spoke with the occupants and determined the call to be accidental.

9/29	Waterford Pk.	Burglary	The complainant states that sometime during the weekend, an unknown person(s) entered his shed and stole items from inside.
9/29	Whitehaven Rd.	Property Found	The complainant states that he found a debit card and wished to turn it over to patrol. Deputies were able to contact the owner and the property was returned.
9/30	Whitehaven Rd.	Trespass	The complainant states that a male subject was parked on the property of WUTV Fox 29. The subject was advised and left without incident.
9/30	Huth Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
9/30	Harvey Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident at the intersection of Park Pl. 1 Driver was transported to a local hospital with seemingly non-life threatening injuries.
9/30	Broadway	Suspicious Incident	The complainant states that earlier in the day, an unknown male subject came to the door looking for a female that did not live at the house. The male left without incident after being advised by the complainant that the female did not reside there.
9/30	Grand Island Blvd.	Youth Activity	The complainant states that 2 youths were wandering around the property of his apartment complex. Deputies located the youths and determined they lived in the complex.
9/30	East River Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
9/30	White Oak Ln.	Suspicious Vehicle	The complainant states that a white van drove through the neighborhood several times and appeared to be suspicious. Deputies checked the area but were unable to locate the vehicle by the description given.
10/1	Ransom Rd.	Traffic Complaint	The complainant states that a vehicle was driving erratically and tailgating other cars on the roadway. Deputies checked the area but were unable to locate the vehicle by the description given.
10/1	Luther La.	Suspicious Person	The complainant states that a male subject she did not recognize was knocking on her door. Deputies located the male subject and determined that it was a friend of the complainant.
10/1	Industrial Dr.	Suspicious Incident	The complainant states that 2 male subjects were loading pallets into a vehicle at a nearby closed business. Deputies located the subjects who stated they worked for the company and were hired to remove the pallets.
10/2	Staley Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
10/2	Grand Island Blvd.	Suspicious Person	The complainant states that 2 male subjects were hanging around the building of a closed business. Deputies located the subjects and determined they were awaiting the arrival of the bus.
10/2	Baseline Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of the Town Hall Terrance apartment complex. No injuries were reported.
