The Erie County Sheriff's Office responded to 158 calls the week of this report. Below is a sampling of the noteworthy incidents on **<u>Grand Island</u>**.

When the employees told him to leave, the male cursed at them and then left the scene. Employees were able to obtain a license plate of the subject's vehicle. Deputies spoke with the subject at his residence and advised him he was no longer welcome on the property. |
