The Erie County Sheriff's Office responded to 204 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
10/31	Baseline Rd.	Noise Complaint	The complainant states that she could hear a loud noise similar to a jackhammer in the parking lot of her apartment complex during the late hours of the night. Deputies checked and determined the complaint was unfounded.
10/31	Love Rd.	Drunk Driving	The complainant states that a female driver was passed out at the wheel in the parking lot of 7-11. Deputies investigation led to the arrest of 24 y/o Patricia Oswald of Grand Island for Driving while Intoxicated and other traffic infractions. Oswald registered a .17% B.A.C. after submitting to a breathalyzer test. Oswald was issued an appearance ticket returnable to the Town of Grand Island Court and released to a sober 3 rd party.
10/31	Whitehaven Rd.	Property Found	The complainant states that he found a wallet and wanted to turn it over to Patrol. Deputies made contact with the owner of the wallet using identification found inside and the property was returned.
10/31	Center Court N.	Larceny	The complainant states that his roommate broke into the bedroom of his apartment and stole various items from inside. Investigation Ongoing.
10/31	Alt. Blvd	Youth Activity	The complainant states that several youths were climbing up a utility pole. Deputies located the youths and advised them.
10/31	East River Rd.	Suspicious Person	The complainant states that 3 teenagers came to her door with no costumes on and appeared to be trick or treating during the late evening hours. Deputies located the subjects nearby and advised them.
11/1	Grand Island Blvd.	Suspicious Incident	The complainant states that she heard someone walking on the roof of the Jade Inn Motel during the late hours of the night. Deputies checked and determined the complaint was unfounded.
11/1	Cardinal La.	Animal Loose	The complainant states that he found a dog running loose in his yard. The Dog Control Officer was notified.

11/1	Lakeview Terr.	Criminal Mischief	The complainant states that sometime during the night, an unknown person(s) keyed his vehicle causing minor damage.
11/1	Grand Island Blvd.	Suspicious Incident	The complainant states that the door at First Niagara Bank leading from the foyer into the closed business appeared to be bent. Deputies checked and were able to secure the door.
11/1	Regency Dr.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident involving a tree. No injuries were reported.
11/1	Bedell Rd.	Residential Burglary	The complainant states that sometime during the day, an unknown person(s) broke into his apartment by pushing open a screen window and stole numerous items from inside.
11/1	Grand Island Blvd.	Suspicious Vehicle	Deputies located an unoccupied vehicle in the parking lot of a closed business during the late evening hours. The business was checked and no signs of a disturbance were observed.
11/2	Grand Island Blvd.	Open Door	Deputies located an unsecure door at Brick Oven Pizza during the late hours of the night. The business was searched but no subjects or signs of a disturbance were observed inside.
11/2	Grand Island Blvd.	Suspicious Person	The complainant states that a male subject was in the parking lot of Tops yelling and banging on the carts in the lot. Deputies checked the area but were unable to locate the subject by the description given.
11/2	East River Rd.	Criminal Mischief	The complainant states that sometime in recent days an unknown person(s) spray painted a political sign in the neighborhood.
11/2	Whitehaven Rd.	Traffic Arrest/Warrant Arrest	Following an investigation of a suspicious vehicle, Deputies arrested 22 y/o Jeffrey Glavin of Niagara Falls for Aggravated Unlicensed Operation 3 rd Degree after a DMV check showed his license was currently suspended. Glavin was also found to have an outstanding warrant from the City of Buffalo. Glavin was issued an appearance ticket returnable to the Town of Grand Island Court and transferred to the custody of the Buffalo Police Department.
11/2	Grand Island Blvd.	Accident Hit & Run	The complainant states that her vehicle was struck in the parking lot of Tops while she was shopping by an unknown vehicle which then fled the scene. No injuries were reported.
11/2	East Park Rd.	Warrant Arrest	Following an investigation of an unrelated complaint, Deputies arrested 35 y/o Samuel Insalaco of Grand Island after a check showed he had an outstanding warrant from the Town of Grand Island. Insalaco was transported to the Erie County Holding Center.
11/2	Stony Point Rd.	Traffic Arrest	Following a traffic stop, Deputies arrested 25 y/o Ryan Samland of Grand Island for Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Samland was issued an appearance ticket returnable to the Town of Grand Island Court.
11/3	Stony Point Rd.	Suspicious Vehicle	The complainant states that a dark colored car was

			parked the wrong way on the road and thought it was suspicious. Patrol located the vehicle but did not observe anything out of order.
11/3	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 3 car motor vehicle accident. No injuries were reported.
11/3	East River Rd.	Suspicious Person	The complainant states she observed a male subject walking through numerous backyards in the neighborhood. Deputies checked and determined it was an employee from National Fuel.
11/3	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of a business. No injuries were reported.
11/3	Stony Point Rd.	Suspicious Person	The complainant states that a male subject was walking through numerous front yards in the neighborhood. Deputies located the subject nearby and determined he was delivering phone books in the area.
11/3	Whitehaven Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
11/3	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 3 car motor vehicle accident in the parking lot of Wendy's. No injuries were reported.
11/4	Alt Blvd.	Suspicious Incident	The complainant states that 3 ATV's were operating near his property and did not believe they had permission from the owner to be on the land. Deputies checked but were unable to locate the ATV's.
11/4	East Park Rd.	Suspicious Person with vehicle	Deputies located a suspicious vehicle going house to house in the neighborhood during the late hours of the night. It was determined the driver was picking up election signs.
11/4	Staley Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
11/5	Grand Island Blvd.	Suspicious Person with Vehicle	Deputies located an occupied vehicle parked behind a closed business during the early morning hours. The driver was an employee who was opening the business for the day.
11/5	Love Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
11/5	Love Rd.	Suspicious Incident	The complainant states that while she was leaving for work, a male subject approached her and asked her for a ride. The complainant did not give the male a ride but was concerned when she left he might try to do something to her residence. Deputies checked the area but were unable to locate the subject by the description given. The complainant's residence was secure and in order.
11/5	Riverdale Dr.	Suspicious Person	The complainant states there was a male subject going door to door soliciting to save people money on their utility bills. Deputies located the subject and determined he had all the appropriate paperwork from the Town of Grand Island to solicit in the area.
11/5	Staley Rd.	Traffic Complaint	The complainant states that a vehicle was swerving and almost struck her as they were driving down the road. Deputies checked the area but were unable to locate the

			vehicle by the description given.
11/5	West River Rd.	Accident PDO	Deputies responded to a report of a 3 car motor vehicle accident. No injuries were reported.
11/6	I-190	Traffic Arrest	Following a traffic stop, Deputies arrested 54 y/o Curtis McKinzie of Buffalo for Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor), Operating a Vehicle with a Suspended Registration (Misdemeanor) and other traffic infractions after a DMV check showed his license and registration were currently suspended. McKinzie was issued an appearance ticket returnable to the Town of Grand Island Court.
11/6	Whitehaven Rd.	Traffic Complaint	The complainant states that a vehicle cut across numerous lanes of traffic almost causing an accident. Deputies checked the area but were unable to locate the vehicle by the description given.
11/6	Grand Island Blvd.	Traffic Arrest	Following a traffic stop, Deputies arrested 46 y/o Margaret Vucetic of Grand Island for Aggravated Unlicensed Operation 2 nd Degree (Misdemeanor), Circumventing an Interlock Control Device (Misdemeanor) and other traffic infractions after a DMV check showed her license was currently revoked. Vucetic was transported to the Erie County Holding Center in lieu of \$200 bail.
11/6	Love Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
