The Erie County Sheriff's Office responded to 309 calls the week of this report. Below is a sampling of the noteworthy incidents in **Grand Island**.

Date	Type	Street	Narrative
11/2	Larceny	Long Rd.	Deputies responded to a reported theft of cash at the homeowner's farm market. Complainant has video of the suspect and incident. Homeowner would like the suspect trespassed and the money returned if located. Patrol is investigating further.
11/3	Larceny in Progress	Grand Island Blvd	Deputies received a call of two suspects stealing items from a store and leaving in a silver Jeep. The vehicle fled prior to patrol's arrival. A suspect was developed through investigation and contact was made with the suspect. The investigation is ongoing.
11/4	Unwelcome Guest	Love Rd	Deputies were called by a business employee about a subject throwing items at the door. The subject was asked to leave the business earlier and returned at this time. The subject was not allowed in by staff. The subject fled prior to patrols arrival. The complainant would like the subject advised not to return to the establishment.
11/5	DWI/Alcohol	I-190 @ Long Rd.	Deputies initiated a traffic stop of a vehicle after observing vehicle and traffic violation(s). Deputies noticed the vehicle operator exhibited signs of intoxication. Deputies performed standardized field sobriety tests and the driver was taken into custody. Driver refused to submit to a breath test. Driver was charged with DWI as well as having a suspended license and a traffic violation. The subject was released on traffic tickets and the vehicle was placed under a twelve-hour hold.
11/7	Accident/Unlicensed Driver	Whitehaven Rd.	Deputies received a call of a truck on its side on Whitehaven Rd. Patrol arrived and found the driver on scene uninjured. Driver was found to have a suspended license and was detained. Driver was also towing an unregistered trailer which appears to have been sent to auction. Patrol is investigating the trailer further. Driver released with citations.
11/8	Traffic Inf - Other	I-190 @ Whitehaven Rd.	Deputies initiated a traffic stop on a gray GMC Yukon and found the registration to be expired by 3 years. Driver of vehicle was detained for a revoked license and the passenger was detained for a possible warrant. Driver was arrested,

			issued tickets, and released. The passenger was turned over to Niagara Falls PD for an active warrant.
