

Erie County Sheriffs Office Media Release Summary

Dates: 11/10/2012 to 11/16/2012

The Erie County Sheriff's Office responded to 165 calls the week of this report. Below is a sampling of the noteworthy incidents on **<u>Grand Island</u>**.

11/10	Love Rd.	Suspicious Person	Deputies located a suspicious person in the Say Cheese parking lot that appeared to be looking into vehicles. The subject was advised.

11/11	Stony Point Rd.	Loud Music	Complainant states that loud music was coming from a residence in the neighborhood. Deputies located the source and advised the occupants.
11/11	Alvin Rd.	Larceny	Employees of Fucillo state that an unknown person(s) stole a tailgate from a vehicle on the lot. Investigation Ongoing.
11/11	Love Rd.	Reckless Operation	Complainant states that 2 vehicles were speeding down the street. Deputies checked the area but were unable to locate the vehicles.

11/15	Grand Island Blvd.	Burglary	Complainant states that sometime during the night, an unknown persons(s) stole various items from the Fantasy Island Amusement Park after making entry by forcing open a window. Investigation Ongoing.
11/15	Baseline Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call at a residence on Baseline Rd. Deputies spoke to the occupants and determined the call to be a misdial.

Their investigation led to the arrest of 39 y/o Wendy Herbst of Grand Island for Felony Driving While Intoxicated and other traffic infractions. Herbst was charged with the Felony DWI due to a prior conviction. Herbst refused to submit a sample of her breath for chemical analysis and was transported to the Erie County Holding Center pending arraignment in the Town of Grand Island Court.
