Forgery	While investigating the above listed Warrant Arrest, Deputies also charged 22 y/o Katie Seibert for Criminal Possession of a Forged Instrument 1 st Degree (Class C Felony) after she was found to be in possession of a forged check. Seibert was transported to the Erie County Holding Center pending her arraignment in the Town of Grand Island Court.
11/15	West River Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants and determined the call to be a misdial.
11/15	East River Rd.	Suspicious Vehicle	The complainant states that a suspicious vehicle was driving up and down the street and a male occupant was hanging something out of the window. Deputies located the vehicle and determined the subjects were working for a local company and dropping off phone books while digitally marking houses that received the items.

Traffic Arrest	Following a traffic stop, Deputies arrested 24 y/o Sarah Chong of Grand Island for Operating a Motor Vehicle with a Suspended Registration (Misdemeanor) and other traffic infractions.
