The Erie County Sheriff's Office responded to 181 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

11/17	Love Rd.	Marijuana Possession	Deputies investigation of a traffic stop, led to the arrest of a Juvenile Offender for Unlawful Possession of Marijuana. The Juvenile Offender was issued an appearance ticket returnable to the Town of Grand Island Court.
11/17	Grand Island Blvd.	Drunk Driving	Following an investigation of a 1 car motor vehicle accident, Deputies arrested 31 y/o Eric Grabenstatter for Driving While Intoxicated and other traffic infractions. Grabenstatter registered a .24% B.A.C., 3 times the legal limit, after submitting a sample of his breathe for chemical analysis. Grabenstatter was charged with Aggravated Driving While Intoxicated, due to the elevated reading, and was issued an appearance ticket returnable to the Town of Grand Island Court. He was then released to the custody of a sober 3 rd party.

11/17	Orchard Rd.	Criminal Mischief	Several neighbors reporting damage to mailboxes that occurred sometime during the night.
11/17	Stony Point Rd.	Assault	Following a disturbance, Deputies arrested 20 y/o Sean Riordan for Assault 2 nd Degree (Class D Felony), Menacing 2 nd Degree (Class A Misdemeanor) and Criminal Possession of a Weapon 4 th Degree (Class A Misdemeanor) after Riordan attacked a friend with a knife. Riordan was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court. The victim was treated on scene by the Grand Island Fire Department for a seemingly non-life threatening laceration.
11/17	Grand Island Blvd.	Shoplifting	Employees at Tops state that an unknown male subject entered the store and stole various merchandise. Investigation Ongoing.
11/17	Enola Rd.	Reckless Operation	Complainant states that a vehicle was driving over peoples lawns in the neighborhood. Deputies located the vehicle and issued the driver several traffic tickets.
11/18	Broadway	Injury Accident	Deputies responded to a report of a 1 cat motor vehicle

			accident with injury. The driver of the vehicle was transported to a local hospital with seemingly non-life threatening injuries.
11/18	Long Rd.	Suspicious Vehicle	Deputies located a suspicious vehicle parked on the property of the Dunlop Corp building. The driver stated he stopped to make a phone call. He was advised and left without incident.
11/18	Fix Rd.	Warrant Arrest	Deputies arrested a Juvenile Offender on a Bench Warrant from the Town of Grand Island Court. The Juvenile Offender was transported to the Erie County Holding Center.

The Juvenile Offender registered a .14% B.A.C. after submitting a sample of his breath for chemical analysis. The Juvenile Offender was issued an appearance ticket returnable to the Town of Grand Island Court and released to a sober 3 rd party.
