The Erie County Sheriff's Office responded to 173 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

11/14	Whitehaven Rd.	Suspicious Vehicle	Deputies located a vehicle parked in the lot of Trinity United Methodist Church during the late hours of the night. No persons were observed in the area and the building was secure.
11/14	Huth Rd.	Suspicious Incident	The complainant states he heard glass break and 2 men arguing in the street before leaving on westbound on foot during the late hours of the night. Deputies checked the area but were unable to locate any broken glass or subjects in the area.

11/16	East River Rd.	Youth Activity	Deputies received several calls during the late hours of the night about a group of subjects who were going door to door and entering garages in the area. Deputies located all of the subjects involved nearby and determined the subjects were carrying out a form of hazing from a fraternity at the University of Buffalo. Deputies contacted the U.B. Police who assisted and all of the subjects were taken back to their respective residences. No criminal charges were filed at the time of the initial incident.
11/17	Bonnywoods Crt.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants and determined the call to be a misdial.
11/17	Wallace Dr.	Larceny	The complainant states that sometime during the day, known subjects stole various items from her residence. Investigation Ongoing.
11/18	Staley Rd.	Traffic Complaint	The complainant states that a vehicle was swerving all over the roadway. Deputies checked the area but were unable to locate the vehicle by the description given.
11/19	Grand Island Blvd.	Drunk Driving	Following a traffic stop, Deputies arrested 66 y/o Randy Cook of Grand Island for Driving While Intoxicated and other traffic infractions. Cook registered a .16% B.A.C. after submitting a sample of his breath. Cook was issued an appearance ticket returnable to the Town of Grand Island Court and released to the custody of a sober 3 rd party.
11/19	Stony Point Rd.	Accident Hit & Run	The complainant states that sometime during the night, an unknown vehicle struck his mailbox and drove over his lawn before fleeing the scene.
11/19	Baseline Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
11/19	River Oaks Dr.	Suspicious Person	The complainant states that a male subject was going door to door asking for residents to conduct a survey. Deputies located the male subject nearby and determined he had a permit to solicit.
11/19	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Noco. No injuries were reported.
11/19	Bush Rd.	Menacing	The complainant states that after a dispute, one of his employees threatened to shoot him while holding an object the complainant thought was a gun. Deputies determined there was no gun involved but their investigation led to the arrest of 25 y/o Jim Anders of Lockport for Menacing 3 rd Degree (Class B Misdemeanor). Anders was transported to the Erie

		County Holding Center pending his arraignment in the
		Town of Grand Island Court.

		backyard dressed like bums and sleeping on the porch.
		The subjects fled the area in an unknown direction when
		the complainant knocked on his window. Deputies
		checked the area but were unable to locate the subjects
		by the description given.
Grand Island Blvd.	Accident Hit & Run	Deputies responded to a report of a hit & run accident in
		the parking lot of Brick Oven Pizza during the late hours
		of the night. The suspect vehicle hit a parked car and
		fled the scene but a witness was able to take a
		photograph of the license plate. Deputies located the
		vehicle parked at the registered owners address but were
		unable to raise anyone at the residence. The vehicle was
		towed and impounded.
Birkshire Dr.	Suspicious Person	The complainant states that an unknown male subject
		was knocking on her door and then left after she did not
		answer. Deputies located the subject nearby and
		determined he was a contractor conducting work in the
		area.
Baseline Rd.	Accident PDO / Traffic Arrest	Deputies responded to a report of a 1 car motor vehicle
		accident. No injuries were reported. Their investigation
		led to the arrest of the driver, 39 y/o Jose Arroyo of
		Buffalo for Aggravated Unlicensed Operation 3 rd Degree
		(Misdemeanor) and other traffic infractions. Arroyo was
		issued an appearance ticket returnable to the Town of
		Grand Island Court.
