The Erie County Sheriff's Office responded to 139 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

11/16	Grand Island Blvd	Suspicious Incident	The complainant states that a vehicle was following a female who was walking. Deputies spoke to the female and the driver of the vehicle and determined the two knew each other and were having a verbal disagreement. All parties were advised.
11/16	Bedell Rd.	Hunting Complaint	The complainant states that 3 male subjects entered the woods near her apartment complex and appeared to be hunting. The complainant felt they were too close to the complex. Deputies checked the area but were unable to locate the subjects.
11/16	Island Park Ct.	Suspicious Person with vehicle	The complainant states that a suspicious vehicle was parked on the street in front of her residence and appeared to be occupied. Deputies spoke to the driver of the vehicle who stated she was waiting for a friend.
11/16	Park La.	Reckless Operation	The complainant states that a white pickup truck was speeding up and down the street. Deputies checked the area but were unable to locate the vehicle.
11/16	Stony Point Rd.	Road Obstruction	The complainant states that kids in the area were putting bags of leaves in the street. Deputies determined the complaint to be unfounded.
11/16	Love Rd.	Loud Music	The complainant states that loud music was coming from Say Cheese Pizza. Deputies spoke to and advised employees on location.
11/17	Whitehaven Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
11/17	Park Pl.	Illegal Dumping	The complainant states that a construction company building a residence in the area was dumping things on her land. Deputies were unable to speak with the workers as they were not currently working during the time of the complaint.
11/17	East River Rd.	Open Burning	The complainant states that a nearby residence was burning leaves. Deputies spoke to the subjects and advised them.
11/17	Sandpiper La.	Welfare Check	Deputies responded to a 911 hang up call. It was determined the occupants were attempting to dial an out

			of country number.
11/17	East River Rd.	Burglary	Deputies responded to a Burglary Alarm at the Buffalo Launch Club. A check of the premise revealed an open door and Deputies checked but no subjects found inside however it was determined the business had been burglarized. Investigation Ongoing.
11/18	East River Rd.	Wire Down	Deputies responded to a report of a wire down. Verizon was notified.
11/18	East River Rd.	Wires Down	Deputies responded to a report of a wire down. Time Warner Cable was notified.
11/18	Baseline Rd.	Animal Loose	The complainant states that a dog was running loose in the neighborhood. The Dog Control Officer was notified.
11/18	Grand Island Blvd.	Warrant Arrest	Deputies arrested 23 y/o William Innes of Grand Island on two outstanding warrants. Innes was also charged with Obstruction of Governmental Administration 2 nd Degree (Class A Misdemeanor). Innes was transported to the Erie County Holding Center.
11/18	Grand Island Blvd.	Obstruction Arrest	While investigating the above Warrant Arrest, Deputies arrested 43 y/o Gregory Swan of Grand Island for Obstruction of Governmental Administration 2 nd Degree (Class A Misdemeanor). Swan was issued an appearance ticket returnable to the Town of Grand Island Court.
11/19	Baseline Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants and determined the call to be a misdial.
11/19	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
11/19	Stony Point Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
11/19	Alt. Blvd.	Pistol Permit Investigation	Deputies conducted a background check for a subject who applied for a pistol permit.
11/20	Love Rd.	Criminal Mischief	The complainant states that sometime in recent days, an unknown person(s) cut the lock to the storage shed on his property. Nothing was reported stolen.
11/20	Broadway	Drunk Driving	Following a traffic stop, Deputies arrested 22 y/o Krista Goff of Grand Island for Driving While Intoxicated and other traffic violations. Goff registered a .10% B.A.C. after submitting a sample of her breath for chemical analysis. Goff was issued an appearance ticket returnable to the Town of Grand Island Court and released to a sober 3 rd party.
11/20	Grand Island Blvd.	Reckless Operation	The complainant states that a vehicle entered the roundabout at a high rate of speed and drove over the curb. Deputies checked the area but were unable to locate the vehicle. No damage was observed.
11/21	Grand Island Blvd.	Suspicious Person with Vehicle	An employee of Wendy's states that two vehicles were parked behind the business and appeared to be occupied by several subjects during the late hours of the night. Deputies spoke to the subjects who stated they were using the wifi offered by the business.
11/21	Grand Island Blvd.	Suspicious Vehicle	An employee of Fantasy Island states that a vehicle was

			parked in the lot during the late hours of the night.
			Deputies spoke to the occupant who was completing
			construction work in the area and parked to get some
			rest. The subject was advised and left without incident.
	East River Rd.	Suspicious Incident	The complainant states that during the night, 3 male
			subjects rang his door bell and were inquiring how to get
			to Niagara Falls. The complainant pointed them in the
11/21			general direction and the males left on foot. The
			complainant only wished to convey the information to
			patrol and was advised to call the police if another
			similar incident should occur.
11/22	Ransom Rd.	Larceny	The complainant states that sometime in recent hours an
			unknown person(s) stole various items from her vehicle
			while it was parked at the Grand Island High School.
	Ransom Rd.	Suspicious Person with Vehicle	The complainant states a vehicle was parked in the lot of
11/22			Grand Island High School during the evening hours and
11/22			appeared to be occupied. Deputies located the vehicle
			and advised the driver.
11/22	East River Rd.	Larceny	The complainant states that several hours ago an
			unknown person(s) stole various items from her vehicle
			by smashing a window to gain entry. After further
			investigation it was determined the incident occurred in
			the City of Buffalo. The complainant was referred to the
			Buffalo Police Department.
