

Erie County Sheriffs Office Media Release Summary Dates: 10/25/2014 to 10/31/2014 Pages: 3

The Erie County Sheriff's Office responded to 157 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

10/25	Whitehaven Rd.	Disorderly Person	Employees of Byblos Niagara Resort & Spa state that a guest of the hotel was not listening to security on site and was causing a disturbance. Deputies spoke with the subject and advised him. Employees allowed the guest to stay.
10/25	Love Rd.	Larceny	Employees of Sunoco state that a subject left the store without paying for gas. Deputies located the vehicle using the plate number provided by the employee. The driver of the vehicle returned to pay for the fuel as it was determined to be an error with the credit card authorization.
10/25	Riverdale Dr.	Animal Bite	The complainant states that her son was bitten by a dog. The Dog Control Officer was notified.
10/25	Cottagewood La.	Suspicious Vehicle	The complainant states that a suspicious vehicle was parked in front of her residence near the dead end. Deputies located the vehicle but were unable to locate the owner.
10/25	East River Rd.	Suspicious Person with Vehicle	Deputies located a suspicious vehicle parked at Fisherman's Landing during the late hours of the night. The occupants of the vehicle were advised and left without incident.
10/26	Whitehaven Rd.	Customer Trouble	Employees from Byblos Niagara Resort & Spa state that the occupants of one of the rooms were playing loud music and causing a ruckus during the late hours of the night. Deputies spoke with the occupants and advised them.
10/26	East River Rd.	Youth Activity	The complainant states that a vehicle was parked at a residence across the street and it did not belong there during the late hours of the night. Deputies located the vehicle and advised the occupants who left without incident.
10/26	Whitehaven Rd.	Customer Trouble	Employees of Byblos Niagara Resort & Spa state that several guests were knocking signs off the wall and discarding refuse in the hallways. Deputies checked the premise but were unable to locate any of the subjects involved.

10/26	East River Rd.	Road Obstruction	Deputies removed a large tree branch from the roadway that was causing a traffic hazard.
10/26	Whitehaven Rd.	Suspicious Person with Vehicle	The complainant states that a vehicle was parked in front her residence and also reported the vehicle was parked there the day before. Deputies located the vehicle but were unable to locate the owner.
10/27	Beaver La.	Assist Other Police	Deputies assisted the Buffalo Police Department in locating a female subject who was involved in a larceny. The female was located by Deputies and turned over to the custody of the Buffalo Police Department.
10/27	Baseline Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident involving a building. No injuries were reported and minimal damage was done to the structure of the building.

Traffic Arrest	Following a traffic stop, Deputies arrested 26 y/o Yannick Ngarambe of Buffalo for Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor) and other traffic infractions after a DMV check showed his license was currently suspended. Ngarambe was transported to the Erie County Holding Center in lieu of \$250 bail.
10/27	Whitehaven Rd.	Suspicious Vehicle	The complainant states that a vehicle was parked in the rear of the WUTV Fox 29 Building. Deputies checked the area but were unable to locate the vehicle.
10/28	Pin Oak Cr.	Suspicious Person with Vehicle	The complainant states that a vehicle was driving through the neighborhood several times. Deputies located the vehicle and determined the driver was looking for his runaway dog.
10/28	East River Rd.	Criminal Mischief	The complainant states that sometime during the weekend an unknown person(s) threw outdoor furniture into the pool.
10/28	Huth Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
10/28	East River Rd.	Animal Loose	The complainant states that a dog was running loose in his backyard. The Dog Control Officer was notified.
10/28	Fix Rd.	Suspicious Incident	Several neighbors state that sometime during the night, an unknown person(s) entered their unlocked vehicles. Nothing was reported stolen.
10/28	Fix Rd.	Larceny	The complainant states that sometime during the night, an unknown person(s) entered his unlocked vehicle and stole the stereo system from the console. Investigation Ongoing.
10/28	Baseline Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
10/28	Love Rd.	Animal Loose	The complainant states that she found a dog in her yard. The Dog Control Officer was notified.
10/28	Whitehaven Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call at Byblos Niagara Resort & Spa. Deputies spoke with the occupants of the room the call originated from and determined the call was a misdial.
10/29	Harvey Rd.	Animal Loose	The complainant states that his dog got loose and was running through the neighborhood. The dog was reunited with the owner.

10/29	I-190	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
10/29	Ransom Rd.	Suspicious Vehicle	Deputies located a subject driving on a golf cart at Grand Island High School during the late evening hours. Deputies determined the subject was an employee that was checking the premise.
10/30	Staley Rd.	Suspicious Vehicle	The complainant states that a white van was driving through the neighborhood and seemed suspicious. Deputies checked the area but were unable to locate the vehicle.
10/30	Whitehaven Rd.	Larceny	The complainant states that while he was shopping at Gui's Lumber an unknown person(s) stole various tools from his lockbox of his pickup truck. Investigation Ongoing.
10/30	Lang Bd.	Suspicious Vehicle	The complainant states that a vehicle was in the parking lot of a closed business and had extensive damage. Deputies were able to contact the driver of the vehicle and determined the vehicle was involved in an accident. No injuries were reported.

Traffic Arrest / Marijuana Possession	Following a traffic stop, Deputies arrested 26 y/o Mark Lucas of Buffalo for Driving a vehicle with a Suspended Registration (Misdemeanor), Unlawful Possession of Marijuana (Violation) and traffic infractions. Also arrested was the passenger 34 y/o Timothy Reynolds of Grand Island for Unlawful Possession of Marijuana (Violation). Both subjects were issued appearance tickets returnable to the Town of Grand Island Court.
10/30	Staley Rd.	Suspicious Incident	The complainant states that a vehicle pulled into the radio station lot during the late hours of the night. The vehicle left prior to the arrival of Patrol. Deputies checked the area but were unable to locate the vehicle by the description given.
10/31	Broadway	Suspicious Person	The complainant states that 2 youths were dressed in all black and were walking in the area of South State Pkwy. during the late hours of the night. Deputies checked the area but were unable to locate the subjects.
10/31	East River Rd.	Suspicious Vehicle	The complainant states that a red pickup truck was driving through the neighborhood acting suspiciously. Deputies checked the area but were unable to locate the vehicle by the description given.
10/31	I-190	Accident Injury	Deputies responded to a report of a 1 car motor vehicle accident. The driver of the vehicle was transported to a local hospital with seemingly non-life threatening injuries.
