

## **Erie County Sheriffs Office Media Release Summary**

The Erie County Sheriff's Office responded to 162 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

11/29	Stony Point Rd.	Warrant Arrest	Deputies arrested 22 y/o Sean Riordan of Grand Island after serving an arrest warrant at his residence. Riordan was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.
11/30	Ransom Rd.	Suspicious Vehicle	An employee of Grand Island High School states there was a suspicious vehicle parked in the back lot of the school. Deputies were able to make contact with the owner who stated the vehicle had broken down and she was making arrangements to have it moved.
11/30	Love Rd.	Fraud	The complainant states sometime yesterday, she noticed that an unknown person made a fraudulent purchase on her debit card.
11/30	Bedell Rd.	Suspicious Vehicle	Deputies located an unoccupied suspicious vehicle parked in Veterans Park during the late evening hours.  No persons were observed in the area.
11/30	Industrial Dr.	Suspicious Vehicle	Deputies located an unoccupied suspicious vehicle at a closed business during the late evening hours. No persons were observed in the area and the business appeared to be secure.
11/30	Grand Island Blvd.	Suspicious Person	The complainant states that a suspicious male subject was walking around Walgreens during the late evening hours. Deputies located the subject who was attempting to make a phone call.
11/30	Ransom Rd.	Suspicious Incident	The complainant states that it appears someone had been tampering with the peephole to her door. Deputies did not see any indication the peephole had become dislodged intentionally by anyone and assisted the complainant with re-securing the device.

Burglary In Progress	The complainant states that 2 known subjects kicked in the door to her apartment while she was home and began to assault her. 1 of the subjects stole a television before both fled in a vehicle waiting outside the apartment building prior to the arrival of Patrol. The complainant was treated on scene by the Grand Island Fire Department for seemingly minor injuries. Investigation

12/1	Baseline Rd.	Warrant Arrest	Deputies arrested a 16 y/o Juvenile Offender on an outstanding Arrest Warrant after she turned herself in at Grand Island Court. The Juvenile Offender was transported to the Erie County Holding Center.
12/1	Love Rd.	Welfare Check	The complainant states that a dog seemed to have been tied up outside for over a day at a nearby residence.  Deputies spoke with the homeowner and determined the dog was let out several times and was not kept outside.  The dog appeared to be in good health.
12/1	Grand Island Blvd.	Welfare Check	The complainant states a male subject who appeared to be handicapped was walking around and did not seem to be dressed appropriately for the cold weather. Deputies checked the area but were unable to locate the subject by the description given.
12/1	Blackmon Rd.	Suspicious Person with Vehicle	The complainant states a suspicious vehicle was driving through the neighborhood multiple times possible casing the area. Deputies located the unoccupied vehicle parked nearby and determined the vehicle belonged to a subject who lived at a nearby residence.

After learning his real name, Deputies discovered Camalleri was wanted on 2 outstanding Bench Warrants from the City of Buffalo and 1 Arrest Warrant from the Erie

	Staley Rd.	Accident Injury	Deputies responded to a report of a 1 car motor vehicle

12/5			a local hospital with seemingly non-life threatening
			injuries.
	Stony Point Rd.	Reckless Operation	The complainant states that 3 vehicles were in a parking
10/5			lot doing donuts and caused minor damage. Deputies
12/5			located 1 of the vehicles nearby. The driver was advised
			as the owner did not wish to pursue any charges.
	Grand Island Blvd.	Suspicious Incident	An employee of Tops states that 2 male subjects came
			into the store and purchased gift cards with credit cards
			he assumed to be stolen. Both male subjects fled the

			unable to locate the vehicle. It was unclear at the time of
			the initial report whether the cards were actually stolen.

			walking on the side of the road yelling obscenities at
			each other during the late hours of the night. Deputies
			checked the area but were unable to locate the males by
			the description given.
