Deputies arrived on location and observed several subjects in the yards on Revere Rd. The subjects immediately began to flee and a short foot chase ensued. Deputies investigation led to the arrest of 3 Juvenile Offenders who were charged with Criminal Trespass 3 rd Degree (Class B Misdemeanor) and Obstruction of Governmental Administration 2 nd Degree (Class A Misdemeanor). The Juvenile Offenders were issued appearance tickets and released to the custody of their parents.
12/11	Long Rd.	Accident Hit & Run	Complainant states that a vehicle struck his and then fled the scene. Sheriffs Deputies and Grand Island Police Officers were able to locate the vehicle and driver. The driver was issued a traffic ticket returnable to the Town of Grand Island Court.

Grand Island Blvd.	Marijuana Arrest	Following a traffic stop and subsequent investigation, Deputies arrested 22 y/o Joseph Grasso of Grand Island for Unlawful Possession of Marijuana and traffic infractions. Grasso was issued an appearance ticket returnable to the Town of Grand Island Court.
Stony Point Rd.	Parking Violation	Deputies cited a vehicle parked in violation of the Grand Island Winter Parking Ordinance.
East River Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
Staley Rd.	Animal Loose	Complainant states he found a dog running loose in the area. The Dog Control Officer was notified.
Colonial Dr. West	Animal Loose	Complainant states he found a dog running loose in the area. The complainant was able to contact the owner and return the dog.

Baseline Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident with injuries. Several subjects were treated on scene for seemingly non-life-threatening injuries.
Grand Island Blvd.	Burglary	Deputies responded to a report of a burglary in progress at Dr. Huggs Car Wash. Employees reported that they noticed the cash register missing. Surveillance footage showed a black male subject entering the business and stealing the register before fleeing in an unknown direction. Investigation Ongoing.
