The Erie County Sheriff's Office responded to 165 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Police investigation deemed the threats to be unfounded, however The Erie County Sheriffs Office and the NYS Troopers increased their presence at the schools as a precautionary measure.
