12/14	Grand Island Blvd.	Warrant Arrest	Following a traffic stop, Deputies arrested 18 y/o Emmanuel Mitchell of Grand Island after a check showed he had an outstanding warrant from the City of Buffalo. Mitchell was turned over to the custody of the Buffalo Police Department.
12/14	Havenwood La.	Animal Complaint	The complainant states that there was a bird in her basement. Deputies were able to remove the bird from the residence.

12/16	Carl Rd.	Traffic Arrest	Following a traffic stop, Deputies arrested 28 y/o Joel Morris of Grand Island after a DMV check showed his license was currently suspended. Morris was charged with Aggravated Unlicensed Operation 2 nd Degree (Misdemeanor) and other traffic infractions. Morris was transported to the Erie County Holding Center in lieu of \$250 Bail.
12/16	Fix Rd.	Snowmobile Complaint	The complainant states that several snowmobiles were operating on her property without permission. Deputies checked the area but were unable to locate the snowmobiles.
12/17	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.

12/18	Grand Island Blvd.	Narcotics Arrest	Following a traffic stop and subsequent investigation, Deputies arrested 21 y/o Alyssa Lori of Ohio, for Criminal Possession of a Controlled Substance 7 th Degree (Class A Misdemeanor) and Possession of a Hypodermic Instrument (Class A Misdemeanor). Lori was transported to the Erie County Holding Center in lieu of \$500 Bail.
12/19	Whitehaven Rd.	Accident Injury	Deputies responded to a report of a 3 car motor vehicle accident. 1 Driver was transported to a local hospital with seemingly non-life threatening injuries.
12/19	Monica Dr.	Suspicious Person	The complainant states that a suspicious male subject appeared to be following a young child who had just got off the school bus. Deputies located the male subject nearby and advised him. The subject left without incident.

12/19	Baseline Rd.	Accident Injury	Deputies responded to a report of a 3 car motor vehicle accident. 1 Driver was treated on scene with seemingly non-life threatening injuries.
12/19	West River Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
12/20	Baseline Rd.	Drunk Driving	Following a traffic stop, Deputies arrested 49 y/o Kenneth Hayes of Amherst for Driving While Intoxicated. Hayes refused to submit a sample of his breath for chemical analysis and is charged with Driving While Intoxicated (Felony for a previous conviction in the last 10 years), Aggravated Unlicensed Operation 1 st Degree (Felony) and numerous traffic infractions. Hayes was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.
12/20	Warner Dr.	Suspicious Vehicle	The complainant states that a vehicle was parked in his driveway that did not belong there and no one appeared to be inside. Deputies contacted the owner and determined AAA had dropped the car off at the wrong residence after being towed from another location.
12/20	Love Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
12/20	South State Pkwy.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
12/20	Grand Island Blvd.	Suspicious Person	The complainant states a suspicious male subject was walking around the Grand Island Plaza asking strange questions to people. The male then left in an unknown direction prior to the arrival of Patrol. Deputies checked the area but were unable to locate the subject
12/20	Whitehaven Rd.	Suspicious Vehicle	The complainant states that a suspicious vehicle was parked in the rear of the Trinity United Methodist Church during the evening hours. Deputies located the vehicle and spoke to the driver who was at the Church for a band practice.
12/20	Baseline Rd.	Suspicious Person	Deputies located a young male subject attempting to hitchhike on Baseline Rd. Deputies contacted the subject's parents and returned him home.
12/20	Fix Rd.	Larceny	The complainant states a known subject was observed stealing a bicycle from the yard of his residence. The subject left in an unknown direction prior to the arrival of Patrol. Investigation Ongoing.
