The Erie County Sheriff's Office responded to 166 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
12/19	Tracey La.	Suspicious Incident	The complainant states that she heard footsteps outside of her residence during the late hours of the night and thought she heard her door handle jiggle. Deputies checked the area but found no persons or signs of a disturbance.
12/19	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident at the intersection of Grand Island Blvd. No injuries were reported.
12/19	Grand Island Blvd.	Suspicious Incident	Employees of Mighty Taco state that an intoxicated male subject came in and was hitting on employees. The subject left prior to the arrival of Patrol. Deputies checked the area but were unable to locate the subject by the description given.
12/19	Baseline Rd.	Suspicious Person with Vehicle	The complainant states that 2 male subjects in a vehicle were driving slowly down the street and occasionally getting out of the vehicle and looking around. Deputies located the 2 subjects who were looking for an acquaintance and unsure of his exact address.
12/19	Stony Point Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
12/19	Glen Avon Rd.	Suspicious Vehicle	The complainant states that 2 vehicles drove onto the pipeline. Deputies checked the area but were unable to locate the vehicles by the description given.
12/20	West River Rd.	Suspicious Person	The complainant states that a female subject came to her door and said she was beat up during the late hours of the night. The female left prior to the arrival of Patrol, who checked the area but were unable to locate her.
12/20	West River Rd.	Suspicious Vehicle	Deputies located a vehicle parked on the median in between the parkway. The driver stated he pulled over to talk on his cell phone.
12/20	The Commons	Suspicious Person	The complainant states that several male subjects were knocking on his door and appeared to be intoxicated during the late hours of the night. Deputies located the subjects nearby and determined they were looking for a friend's house but knocked on the wrong door.

12/21	Baseline Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident at the intersection of Grand Island Blvd. No injuries were reported.
12/21	Alt Blvd.	Animal Loose	The complainant states that a dog was running loose in the neighborhood. The Dog Control Officer was notified.
12/21	Whitehaven Rd.	Suspicious Incident	The complainant states that a white pickup truck was parked on the bank of the river near the Byblos Niagara Resort & Spa and appeared to be dumping items into the water. Deputies located the vehicle and determined the occupants were in the area working on cell towers.
12/21	Grand Island Blvd.	Traffic Arrest	Following a traffic stop, Deputies arrested 57 y/o Wilford Boans of Niagara Falls for Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor), Operating a Vehicle with a Suspended Registration (Misdemeanor) and other traffic infractions after a DMV check showed his license and registration were currently suspended. Boans was issued an appearance ticket returnable to the Town of Grand Island Court.
12/21	Park Pl.	Criminal Mischief	The complainant states that he heard a loud bang near the area of his garage. When he looked outside he saw 2 youths running away from his house and noticed his garage door had been damaged. Deputies checked the area but were unable to locate the subjects by the description given.
12/22	Baseline Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
12/22	Grand Island Blvd.	Traffic Complaint	The complainant states that a vehicle was all over the roadway before exiting the I-190 and heading down Grand Island Blvd. Deputies checked the area but were unable to locate the vehicle by the description given.
12/22	Whitehaven Rd.	Traffic Arrest	Following a traffic stop, Deputies arrested 48 y/o Daniel Pilon Jr. of Grand Island for Aggravated Unlicensed Operation 3 rd Degree (Misdemeanor), Operating a Vehicle with a Suspended Registration (Misdemeanor) and other traffic infractions after a DMV check showed his license and registration were currently suspended. Pilon was issued an appearance ticket returnable to the Town of Grand Island Court.
12/22	Regency Dr.	Accident Hit & Run	The complainant states that sometime in the past hour a vehicle struck his mailbox and fled the scene.
12/22	Whitehaven Rd.	Larceny	The complainant states that several valuable items were stolen from her residence during the past week. Investigation Ongoing.
12/23	Grand Island Blvd.	Customer Trouble	Employees of McDonald's state that a subject was asked to leave the store and refused to do so. Deputies advised the subject who left without further incident.
12/23	East Park Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
12/23	Sixth St.	Shots Fired	The complainant states that he heard several shots fired in the area during the late hours of the night. Deputies checked the area but did not hear any shots.
12/24	Baseline Rd.	Suspicious Incident	The complainant states that he heard voices outside of

			St. Stephens Church during the late hours of the night and when he looked outside he saw a dark colored vehicle speed off. Deputies checked the area but were unable to locate the vehicle by the description given. No damage was observed.
12/24	Baseline Rd.	Larceny	The complainant states that sometime during the night, an unknown person(s) stole some Christmas decorations from her yard.
12/24	Riverview Ct.	Suspicious Incident	The complainant states that he heard his rear door open and when he went to check who it was he saw an unknown male subject fleeing from the scene. Deputies checked the area but were unable to locate the male by the description given. Nothing was reported stolen or damaged.
12/25	Grand Island Blvd.	Marijuana/Narcotics Arrest	Following a traffic stop, Deputies arrested 18 y/o Jonathan Link of Buffalo for Unlawful Possession of Marijuana (Violation), Criminal Possession of a Controlled Substance 7 th Degree (Class A Misdemeanor) and traffic infractions. Link was issued an appearance ticket returnable to the Town of Grand Island Court.
12/25	East River Rd.	Suspicious Incident	The complainant states that an elderly male was down on the ground at a nearby address. Deputies located the male and determined he was doing yardwork.
12/25	Love Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of 7-11. No injuries were reported.
12/25	Love Rd.	Robbery	Employees of Sunoco state that a male subject came into the store with a weapon demanding money. The cashier opened the register and the suspect fled with an undetermined amount of cash. The suspect was identified by surveillance video on premise and the investigation is ongoing.
