The Erie County Sheriff's Office responded to 176 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
11/22	Grand Island Blvd.	Suspicious Person	The complainant states that a male subject was walking behind her apartment building during the late hours of the night. The subject was determined to be a resident of the complex.
11/22	Bedell Rd.	Suspicious Incident	The complainant states that an odor of marijuana was present in the hallway of her apartment complex. Deputies checked the premise and determined the complaint to be unfounded.
11/22	Grand Island Blvd.	Suspicious Vehicle	An employee of Aceti's Wine and Spirits states that a suspicious moving vehicle was sitting outside of the business. The vehicle left prior to the arrival of Patrol. Deputies checked the area but were unable to locate the vehicle by the description given.
11/22	Broadway	Residential Fire	Deputies assisted the Grand Island Fire Department with a report of a house fire. Erie County Sheriff's Office fire investigators were also called to assist. The fire was determined to be accidental. No injuries were reported to any occupants.
11/23	I-190	Suspicious Person	A Toll collector for the Thruway Authority reported a male subject was walking on the South Grand Island Bridge during the late hours of the night and was concerned he may attempt to harm himself. Erie County Sheriff's Office assisted the New York State Police and Town of Tonawanda Police Department in reuniting the male subject with family members.
11/23	Grand Island Blvd.	Disorderly Person	Employees of Tops state that 2 male subjects came into Tops and were attempting to steal Lobsters during the late hours of the night. Deputies located the 2 subjects who were advised and left without incident to the satisfaction of the complainant.
11/23	Grand Island Blvd.	Accident Hit & Run	The complainant states that while he was at Tops, an unknown vehicle struck his parked car in the lot and then fled the scene.
11/24	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident at the intersection of Staley Rd. No injuries were reported.

11/24	Bush Rd.	Wires Down	Deputies responded to a report of wires down and sparking in the roadway. Grand Island Fire Department responded and notified National Grid.
11/25	Grand Island Blvd.	Suspicious Incident	The complainant states that a door was broken off the hinges of a neighboring apartment. Deputies checked the apartment and found it vacant. It was determined after speaking with the owner that the door was damaged recently by weather.
11/25	Baseline Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
11/25	Grand Island Blvd.	Accident Hit & Run	The complainant states that while she was at a local business yesterday, an unknown vehicle struck her parked car and fled the scene.
11/25	White Tail Run	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke with the occupants and determined the call to be a misdial.
11/26	Royal Oak Cr.	Youth Activity	The complainant states that several youths were screaming and causing a disturbance in the street during the late hours of the night. Deputies checked the area but were unable to locate the youths by the description given.
11/26	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident in the parking lot of Burger King. No injuries were reported.
11/26	Greenway Rd.	Larceny	The complainant states that sometime during the night, an unknown person(s) stole a tow dolly from the rear of his truck.
11/26	Alt Blvd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
11/26	Flannigan La.	Fraud	The complainant states that his credit card was used at multiple locations and on various dates by an unknown person(s). Investigation Ongoing.

11/27	Grand Island Blvd.	Burglary Alarm / Open Door	Deputies responded to a Burglary Alarm at Burger King. Deputies checked the business and found an open door but no persons were found inside. The open door was determined to be an oversight and the building was secured by a key holder.
11/27	Stony Point Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
11/27	Love Rd.	Criminal Mischief / Marijuana Arrest	The complainant states that 2 vehicles were doing donuts on the grass at Kaegabine Elementary School. Deputies located one of the vehicles nearby. Their investigation led to the arrest of an 18 y/o Juvenile Offender from Grand Island for Criminal Mischief 4th Degree (Class A Misdemeanor) and Unlawful Possession of Marijuana (Violation). The Juvenile Offender was transported to the Erie County Holding Center in lieu of \$250 bail.
11/27	Grand Island Blvd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident. 1 driver was treated on scene for seemingly non-life threatening injuries.
11/27	East River Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle

			accident. No injuries were reported.
11/27	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
11/27	South State Pkwy.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
11/27	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
11/27	Grand Island Blvd.	Accident Hit & Run	The complainant states that a vehicle struck his car and fled the scene. The complainant was able to follow the suspect vehicle until the arrival of Patrol. The driver of the suspect vehicle was issued several traffic citations. No injuries were reported.
11/28	Grand Island Blvd.	Accident Injury	Deputies responded to a report of a 3 car motor vehicle accident. 1 driver was transported to a local hospital with seemingly non-life threatening injuries.
11/28	Love Rd.	Property Found	Employees of 711 state they found a wallet on the floor inside the business. The wallet was turned over to the owner by Deputies.
