



## Erie County Sheriffs Office Media Release Summary

The Erie County Sheriff's Office responded to 167 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
11/23	Whitehaven Rd.	Suspicious Incident	The complainant states that a truck was hooking up a boat at River Oaks Marina during the late hours of the night. Deputies spoke to the driver of the vehicle who was an employee working on slips on the premise.
11/23	Baseline Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
11/23	Love Rd.	Traffic Arrest	Following a traffic stop, Deputies arrested 38 y/o Paul Frederick of Grand Island for Operating a Motor Vehicle while Registration is Suspended (Misdemeanor) and other traffic infractions. Frederick was issued an appearance ticket returnable to the Town of Grand Island Court.
11/23	Stony Point Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
11/23	Grand Island Blvd.	Drunk Driving	Deputies responded to a report of a 3 car motor vehicle accident. Their investigation led to the arrest of 56 y/o Richard Mock of Grand Island for Driving While Intoxicated and other traffic infractions. Mock registered a .14% B.A.C after submitting a sample of his breath for chemical analysis. Mock was issued an appearance ticket returnable to the Town of Grand Island Court and released to a sober 3 <sup>rd</sup> party. One driver from the accident was transported to an area hospital with seemingly minor injuries.
11/24	West River Rd.	Suspicious Incident	The complainant states that she went outside during the early hours of the morning and found her garage door was open. Deputies checked the premise with the complainant and nothing was reported stolen or damaged.
11/24	Tracey La.	Pistol Permit Investigation	Deputies conducted a background check for a subject who applied for a pistol permit.
11/24	Bedell Rd.	Suspicious Person	Deputies observed a male subject digging through the dumpster behind the Grand Island Memorial Library. The subject was advised and left without incident.
11/26	Whitehaven Rd.	Customer Trouble	An employee at Noco states that a customer was causing

			a disturbance. The customer left prior to the arrival of Patrol but Deputies located him nearby. All parties were advised.

Traffic Arrest	Following a traffic stop, Deputies arrested 37 y/o Eric Clear of Farnham for Aggravated Unlicensed Operation 3 <sup>rd</sup> Degree and other traffic infractions after a DMV check showed Clear had a suspended license. Clear was issued an appearance ticket returnable to the Town of Grand Island Court.
11/26	Love Rd.	Suspicious Incident	The complainant states that sometime during the night, an unknown person(s) attempted to break into a trailer on his property by cutting a lock. Nothing was reported stolen.
11/26	East River Rd.	Suspicious Vehicle	The complainant states that a vehicle was parked at a nearby residence that was vacant and up for sale. Deputies spoke with the owner of the vehicle who was on location regarding the sale of the home.
11/26	Grand Island Blvd.	Reckless Operation	The complainant states that a vehicle was all over the roadway. Deputies checked the area but were unable to locate the vehicle by the description given.
11/26	Schwegler Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke with the occupants and determined the called to be a misdial.
11/26	Deerwood La.	Pistol Permit Investigation	Deputies conducted a background check for a subject who applied for a pistol permit.
11/27	Baseline Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.

11/27	Long Rd.	Wire Down	Deputies responded to a report of a wire hanging in the roadway. The wire was removed.
11/27	Carl Rd.	Animal Loose	The complainant states he found a dog running loose with no tags on it. The Dog Control Officer was notified.
11/28	Grand Island Blvd.	Suspicious Incident	Deputies located a business with an open door and searched the premise but found no subjects inside. The manager was notified and responded to secure the building.
11/28	Huth Rd.	Criminal Mischief	The complainant states that sometime during the night, an unknown person(s) slashed a tire on her vehicle.
11/29	Carl Rd.	Suspicious Incident	The complainant states that a male subject dressed in all black was standing at the back door of her neighbor's home during the late hours of the night. The subject left in an unknown direction prior to the arrival of Patrol. Deputies checked the area but were unable to locate any subjects matching the description.
11/29	East River Rd.	Suspicious Incident	The complainant states that water was coming from the walls of a neighboring residence. Deputies were able to gain access to the vacant home and turned off the water supply to the residence.
11/29	Bedell Rd.	Attempted Break In	The complainant states that while she was showering in her home she heard someone attempting to pry open her apartment door. While calling 911 the person fled in an

			unknown direction. Deputies canvassed numerous neighbors about the incident but were unable to gather any pertinent information. Nothing was reported stolen.
11/29	I-190	Warrant Arrest	Deputies were notified that Niagara County Sheriff's Office had arrested 26 y/o Timothy Ormond of Lockport on an outstanding warrant from the Erie County Sheriff's Office. Ormond was transported to the Erie County Holding Center.
11/29	Monica Rd.	Larceny	The complainant states that sometime in recent months an unknown person(s) stole an engagement ring from inside her residence. Investigation Ongoing.
