The Erie County Sheriff's Office responded to 177 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
1/30	Huth Rd.	Burglary	The complainant states that sometime during the night, an unknown person(s) broke into Island United Presbyterian Church and stole numerous items while inside. Investigation Ongoing.
1/30	Stony Point Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
1/30	East River Rd.	Barking Dog	The complainant states that a dog at a neighboring residence was outside barking for the last few hours. Deputies made contact with the occupants who brought the dog inside.
1/30	Grand Island Blvd.	Suspicious Vehicle	Deputies located a vehicle parked in the lot of Bailly's Food market during the late evening hours after the business was closed. The occupant was advised and left without incident.
1/31	West River Rd.	Suspicious Vehicle	The complainant states that a vehicle was parked in the Eagle Overlook during the late evening hours. Deputies located the vehicle and advised the occupants.
1/31	East River Rd.	Suspicious Incident	The complainant states that she came home and thought she saw a male subject near her front window. The male subject entered a vehicle and left the area prior to the arrival of Patrol. Deputies checked the area but were unable to locate any persons involved by the minimal description given.
1/31	Bedell Rd.	Suspicious Vehicle	Deputies located a vehicle parked in the lot of a closed business during the late hours of the night. The owner of the vehicle was on location performing maintenance inside the building.
2/1	Grand Island Blvd.	Suspicious Incident	The complainant states that she thought she heard someone attempting to open the door of her apartment during the late hours of the night. Deputies checked but found no persons or signs of a disturbance.

2/1	East River Rd.	Suspicious Vehicle	The complainant states that a vehicle was parked underneath the south Grand Island Bridge. Deputies located the vehicle and advised the driver.
2/1	Grand Island Blvd.	Accident Hit & Run	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Tops in which one vehicle fled the scene. Deputies located the vehicle at the registered owners address after witnesses were able to obtain a license plate number. No injuries were reported.
2/1	White Tail Run	Suspicious Vehicle	The complainant states that a vehicle was parked on the street with a male subject who was sitting inside for the last 45 minutes during the late evening hours. Deputies located the vehicle, legally parked and unoccupied.
2/2	East River Rd.	Traffic Complaint	The complainant states that numerous vehicles were speeding past her house. Deputies checked the area but found no traffic violations.
2/2	Ward Park Rd.	Suspicious Incident	The complainant states that several packages delivered to his residence had gone missing.
2/2	Havenwood La.	Suspicious Person	The complainant states that 2 male subjects were going door to door asking to see fuel bills from residents in the area. Deputies located the subjects nearby and determined they had the proper paperwork issued from the Town of Grand Island for peddler's license.
2/2	Grand Island Blvd.	Suspicious Incident	The complainant states that a youth on a skateboard grabbed onto a moving bus near the traffic circle. Deputies checked the area but were unable to locate the youth by the description given.
2/2	I-190	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
2/2	Huth Rd.	Suspicious Incident	The complainant states she thought she heard a male voice while inside the Island United Presbyterian Church during the late evening hours. Deputies checked but found no persons inside or signs of a disturbance.
2/2	Baseline Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
2/3	Ferry Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call at Anchor Marine. Deputies checked the premise and found no signs of a disturbance.
2/3	Baseline Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
2/4	East River Rd.	Traffic Arrest	Following a traffic stop, Deputies arrested 19 y/o Evan Nugent of Grand Island for Aggravated Unlicensed Operation 3 <sup>rd</sup> Degree (Misdemeanor) after a DMV check showed his license was currently suspended. Nugent was issued an appearance ticket returnable to the Town of Grand Island Court.
2/4	Morningside Dr.	Suspicious Person with Vehicle	The complainant states that there was an occupied vehicle parked in front of her house for approximately an hour. Deputies located the vehicle and advised the driver.
2/5	Dolphin Dr.	Traffic Arrest	Following a traffic stop, Deputies arrested 42 y/o Jeffrey Khreis of Grand Island for Operating a Motor Vehicle with a suspended registration (Misdemeanor) and other

			traffic infractions after a DMV check showed his registration was currently suspended. Khreis was issued an appearance ticket returnable to the Town of Grand Island Court.
2/5	Bedell Rd.	Suspicious Incident	The complainant states during a transaction on Craigslist, he received a check from an unknown subject who agreed to buy his couch and the check was made out for \$1000 more than originally agreed upon. Deputies advised the complainant it was most likely a scam and to make a report with the online website.
2/5	Grand Island Blvd.	Traffic Arrest	Following a traffic stop, Deputies arrested 32 y/o Jaklin Kuing of Buffalo for Operating a Motor Vehicle with a suspended registration (Misdemeanor) after a DMV check showed her registration was currently suspended. Kuing was issued an appearance ticket returnable to the Town of Grand Island Court.
2/5	Second St.	Animal Loose	The complainant states that his dog got loose and was running around in the neighborhood. The Dog Control Officer was notified.
