

## **Erie County Sheriffs Office Media Release Summary**

The Erie County Sheriff's Office responded to 158 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

1/31	Baseline Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident involving a telephone pole near the intersection of Bedell Rd. No injuries were reported.
1/31	West River Rd.	Suspicious Person	The complainant states that a female subject with a walker was flagging down cars. Deputies checked the area but were unable to locate the female by the description given.

Wylke was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.

Theft Of Services	A taxi driver stated that a male subject fled his cab without paying for the fare in the area of the Town Hall Terrace Apartments during the late hours of the night. The taxi driver gave Deputies the address the male gave to take him to. Deputies were able to follow footprints in the snow which led to the apartment given by the male. The male was located and positively identified by the taxi driver. Deputies arrested 29 y/o John Havens of Grand Island for Theft of Services (Class A Misdemeanor), Obstruction of Governmental Administration 2 <sup>nd</sup> Degree (Class A Misdemeanor) and Disorderly Conduct (Violation). Havens was transported to the Erie County Holding Center pending his arraignment in the Town of Grand Island Court.
