The Erie County Sheriff's Office responded to 214 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
2/6	Ransom Rd.	Noise Complaint	The complainant states that a neighbor in her apartment complex was playing loud music during the late hours of the night. Deputies advised the occupant of the apartment.
2/6	Stony Point Rd.	Suspicious Person with Vehicle	The complainant states that a pickup truck was going in and out of driveways during the late hours of the night. Deputies checked the area but were unable to locate the vehicle by the description given.
2/6	West River Rd.	Suspicious Incident	The complainant states that sometime during the night, an unknown person(s) went thru two unlocked vehicles in the driveway but it did not appear anything was taken.

2/6	West River Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
2/6	Love Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
2/6	Industrial Dr.	Suspicious Person with Vehicle	The complainant states he observed a pickup truck pulling into the lot of a closed business during the late evening hours. Deputies checked the area but were unable to locate the vehicle by the description given.
2/6	Grand Island Blvd.	Suspicious Person with Vehicle	Deputies located a vehicle parked outside of the Island Deli after closing hours. The vehicle was determined to belong to the owner who was on location.

2/7	Grand Island Blvd.	Warrant Arrest	While investigating an unrelated complaint, Deputies arrested 22 y/o Jonathan Oyer of Grand Island after a check showed he had an outstanding bench warrant from the City of North Tonawanda. Oyer was transferred to the custody of the North Tonawanda Police Department.
2/8	Broadway	Animal Loose	The complainant states that he found a loose dog running through the neighborhood. The Dog Control Officer was notified.
2/8	West River Rd.	Animal Loose	The complainant states that he found a dog wandering with no tags. The Dog Control Officer was notified.
2/8	Staley Rd.	Suspicious Vehicle	Deputies located a suspicious vehicle parked at WHLD News station. The owner of the vehicle was determined to be an employee of the company.
2/8	Grand Island Blvd.	Property Found	Employees of Dollar Tree state they found a wallet in the store. Deputies used identification found inside the wallet to locate the owner and returned the wallet.

2/9	Cardinal La.	Accident Hit & Run	The complainant states that a vehicle struck his mailbox and fled the scene. A witness described the vehicle as a black colored SUV. Deputies checked the area but were unable to locate the vehicle involved. Deputies were notified by the complainant during the next day, that a neighbor's son admitting to hitting the mailbox and was going to pay restitution for it.
2/9	Blackmon Rd.	Accident Hit & Run	The complainant states that a vehicle struck his fence sometime during the weekend and fled the scene.
2/11	Stony Point Rd.	Larceny	The complainant states that money was missing from a client's account at People's Inc.
2/11	Baseline Rd.	Suspicious Person	The complainant states that a subject was observed on the 3 <sup>rd</sup> floor balcony of an apartment complex and appeared to be breaking in. Prior to the arrival of Patrol, the subject was let into the residence by another person.
2/11	Riverdale Dr.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke with the occupants and determined the call was a misdial.
2/12	Love Rd.	Accident Hit & Run	An employee of 7-11 states that an orange colored Dodge sedan pulled into the parking lot of the business and struck his parked vehicle before fleeing the scene. Deputies checked the area but were unable to locate the vehicle by the description given.
2/12	Jamestown Rd.	Residential Burglary	The complainant states sometime in recent weeks an unknown person(s) stole various items from inside the residence. Investigation Ongoing.
2/12	Greenway Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
2/12	Bedell Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.

2/12	Bedell Rd.	Suspicious Vehicle / Unlawful Possession of Marijuana	Deputies located a vehicle parked behind the Library in Veterans Park during the late evening hours. Their investigation led to the arrest of 36 y/o Robert Miller of Grand Island for Unlawful Possession of Marijuana (Violation). Miller was issued an appearance ticket returnable to the Town of Grand Island Court.
