

Erie County Sheriffs Office Media Release Summary Dates: 2/7/2015 to 2/13/2015 Pages: 3

The Erie County Sheriff's Office responded to 162 calls the week of this report. Below is a sampling of the noteworthy incidents on **<u>Grand Island</u>**.

2/7	Waterford Pk.	Suspicious Incident	The complainant states that a neighbor's garage door was open during the late hours of the night. Deputies spoke with the homeowner and determined the open door was an oversight.
2/7	I-190	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
2/7	South State Pkwy.	Suspicious Person	The complainant states that 2 subjects on motorized wheelchairs were driving on the roadway over the I-190. Deputies checked the area but were unable to locate the subjects.
2/7	East Park Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke with the occupants and determined the call was a misdial.
2/7	Staley Rd.	Identity Theft	The complainant states that he received a letter from the IRS stating an unknown person(s) was attempting to file a tax return using the complainant's name.
2/7	West River Rd.	Suspicious Person	The complainant states that a female in wheelchair was on the side of the road waving to passing vehicles. Deputies located the subject and advised her.
2/7	Stony Point Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
2/8	Bush Rd.	Accident Injury	Deputies responded to a report of a 2 car motor vehicle accident. 1 driver was treated on scene by the Grand Island Fire Department for seemingly non-life threatening injuries.
2/9	Staley Rd.	Wires Down	Deputies responded to a report of wires down across the roadway. Verizon was notified.
2/9	Grand Island Blvd.	Drunk Driving	Following a traffic stop, Deputies arrested 33 y/o Stephanie Reynolds of Grand Island for Driving While Intoxicated and other traffic infractions. Reynolds registered a .13% B.A.C. after submitting a sample of her breath for chemical analysis. Reynolds was issued an appearance ticket returnable to the Town of Grand Island Court and released to a sober 3 rd party.
2/10	Ransom Rd.	Reckless Operation	The complainant states that a vehicle was doing donuts

			in the parking lot of the Grand Island Market and almost struck one of the fuel pumps. Deputies checked the area but were unable to locate the vehicle by the description given.
2/10	Stony Point Rd.	Accident PDO	Deputies responded to a report of a 3 car motor vehicle accident. No injuries were reported.
2/10	Love Rd.	Suspicious Incident	The complainant states that a male subject was sleeping at the wheel of his vehicle while stopped at the red light at the intersection of Baseline Rd. The vehicle left the scene prior to the arrival of Patrol and was last seen in the area of South State Pkwy. Deputies checked the area but were unable to locate the vehicle by the description given.
2/10	Carl Rd.	Suspicious Vehicle	The complainant states that 3 vehicles were parked near the intersection of South State Pkwy and did not belong there. Deputies checked the area but were unable to locate the vehicles by the description given.
2/10	West River Rd.	Suspicious Person	The complainant states that a female subject was standing on the side of the unlit road and was concerned she may be struck by a car. Deputies located the female and advised her.
2/11	Whitehaven Rd.	Suspicious Person	The complainant states that a male subject walking his dog was cutting through his private business parking lot. The subject was advised and left without incident.
2/11	Stony Point Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
2/11	Bedell Rd.	Suspicious Vehicle	Deputies located an unoccupied vehicle in the parking lot of the Grand Island Memorial Library during the late hours of the night. No driver was observed in the area of the vehicle.
2/12	Town Hall Terr.	Larceny	The complainant states that sometime during the night, an unknown person(s) smashed her car window and stole numerous items from inside.
2/12	Bonnywoods Cr.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
2/12	East River Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call at a residence on East River Rd. Deputies were able to make contact with the residents and determined the call was a misdial.
2/13	Stony Point Rd.	Accident PDO / Drunk Driving	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported. Their investigation led to the arrest of 38 y/o Andrew Christensen of Grand Island for Driving While Intoxicated and other traffic infractions. Christensen registered a .11% B.A.C. after submitting a sample of his breath for chemical analysis. Christensen was issued an appearance ticket returnable to the Town of Grand Island Court and released to a sober 3 rd party.
2/13	Bedell Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident near the intersection of Grand Island Blvd. No injuries were reported.
2/13	Baseline Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.

2/13	Spicer Creek Run	Refer to Patrol	Deputies responded to a report of a water main break on Spicer Creek Run. Deputies checked the area and determined the complaint was unfounded.
2/13	Whitehaven Rd.	Road Obstruction	Deputies removed a vehicle bumper that was left in the roadway and was causing a traffic hazard.
2/13	Grand Island Blvd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled near the intersection of Whitehaven Rd.
2/13	Love Rd.	Larceny	The complainant states that while he was inside Sunoco delivering items to the business, 3 black male subjects stole a large number of cigarette cartons from his truck. The male subjects then fled the area in a vehicle parked nearby. The complainant was able to obtain a license plate number from the vehicle before it fled. Investigation Ongoing.
2/13	Bedell Rd.	Animal Bite	The complainant states she was bitten by a dog while in the area of the Country Glen Apartments. The Dog Control Officer was notified.
