The Erie County Sheriff's Office responded to 160 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

2/9	Baseline Rd	Reckless Operation	Complainant states that a vehicle had driven into a snow bank and briefly become stuck. The driver of the vehicle was able to free the vehicle and left the scene. Deputies checked the area but were unable to locate the vehicle.
