The Erie County Sheriff's Office responded to 201 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

2/13	Whitehaven Rd.	Accident Hit & Run	The complainant states that sometime during the night, a vehicle struck his mailbox and fled the scene leaving behind pieces of the bumper and a license plate. Deputies were able to track down the driver and issued numerous traffic tickets.
2/13	Love Rd.	Fraud	The complainant states that an unknown person(s) in Arizona made fraudulent purchases on her credit card without her authorization.
2/13	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident near the entrance to the I-190. No injuries were reported.
2/14	East River Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
2/14	Grand Island Blvd.	Animal Complaint	The complainant states that a neighbor in a nearby apartment was abusing his dog. Deputies were unable to locate the subject but spoke to numerous other neighbors and determined the complaint was unfounded.
2/14	Ransom Rd.	Suspicious Person	The complainant states that a male subject was stumbling down the road. Deputies checked the area but were unable to locate the subject by the description given.
2/16	Baseline Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
2/16	Grand Island Blvd.	Road Rage	The complainant states that he was threatened by another motorist during a road rage incident. The complainant was able to obtain a license plate but only wanted to notify Patrol of the incident and was not interested in pursuing anything.
2/16	Revere Rd.	Suspicious Incident	The complainant states that the front door of a neighboring house appeared to have fresh damage to it. Deputies spoke with the occupant and determined the damage was old.
2/16	Whitehaven Rd.	Larceny	The complainant states that while he was at Byblos Niagara Resort & Spa an unknown person(s) stole a wallet from his vehicle.

2/16	Bishops Gate Rd.	Snow Removal	The complainant states that a neighbor was snow blowing and throwing snow into the street causing a hazard. Deputies spoke with and advised the homeowner.
2/16	Ransom Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
2/16	Alvin Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
2/16	Grand Island Blvd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
2/17	Marlin Rd.	Suspicious Incident	The complainant states that he found footprints in the snow around his residence. No persons were located in the area.
2/17	Grand Island Blvd.	Traffic Arrest	Following a traffic stop, Deputies arrested 25 y/o Shawna Knight of Grand Island for Aggravated Unlicensed Operation 2 nd Degree (Misdemeanor) and other traffic infractions after a DMV check showed her license was currently suspended. Knight was transported to the Erie County Holding Center in lieu of \$150 bail.
2/17	Long Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
2/17	Schwegler Rd.	Road Rage	The complainant states that while she was on Schwegler Rd. an occupant of another vehicle threw something at her car before fleeing the area. The complainant was able to obtain a license plate for the vehicle. Deputies checked the area but were unable to locate the vehicle. No damage was reported.
2/18	East River Rd.	Suspicious Vehicle	The complainant states that 2 vehicles and a U-haul were parked at River Stone Grill during the late hours of the night while the business was closed. Deputies located the vehicles but no persons were located in the area. The business was checked and appeared to be in order.
2/18	Whitehaven Rd.	Suspicious Person with Vehicle	Deputies located an occupied vehicle parked behind the Golden Age Center during the late evening hours. The occupant was advised and left without incident.
2/18	Bonnywoods Cr.	Suspicious Vehicle	The complainant states that a white van was parked in the street for the last hour and no one was coming or going from it. Deputies located the vehicle but found nothing suspicious.
2/19	East River Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
2/19	Bedell Rd.	Suspicious Incident	The complainant states that a vehicle was parked at a nearby vacant house and the occupants were knocking on the door. The vehicle left prior to the arrival of Patrol. Deputies checked the area but were unable to locate the vehicle by the description given. No damage was observed to the residence.
