The Erie County Sheriff's Office responded to 158 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

2/16	Grand Island Blvd.	Unlawful Possession of Marijuana	Following a traffic stop, Deputies arrested 20 y/o Armend Islami and 20 y/o Anthony Genova both of Grand Island, for Unlawful Possession of Marijuana (a Violation). Both subjects were issued an appearance ticket returnable to the Town of Grand Island Court.
2/16	Center Ct. South	Fraud	Complainant states that an unknown person(s) made a fraudulent purchase with her credit card. Investigation Ongoing.
2/16	Baseline Rd.	Reckless Operation	Complainant states that a vehicle pulled out of TC's Lounge and was driving recklessly down the road. Deputies checked the area but were unable to locate the vehicle.
2/17	Beaver Island State Pkwy.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
2/17	Staley Rd.	Accident Hit & Run	Complainant states that a vehicle hit a telephone pole and then became stuck in the ditch. Deputies were tied up on a priority call and when they got to the scene the vehicle was gone.
2/17	Stony Point Rd.	Suspicious Vehicle	Complainant states that a suspicious vehicle was parked in the fire station parking lot during the late hours of the night. The vehicle left prior to the arrival of Patrol. Deputies checked the area but were unable to locate the vehicle.
2/17	Love Rd.	Criminal Mischief	Complainant states that sometime during the night, an unknown person(s) slashed the tires on his vehicle.
2/18	Love Rd.	Suspicious Vehicle	Employees at 711 state that a suspicious vehicle was parked in the lot and appeared to be occupied. Deputies located the vehicle and identified several subjects inside. Deputies investigation led to the arrest of 19 y/o Jordan Caver of Grand Island for Unlawful Possession of Alcohol by persons under 21, Disorderly Conduct (a Violation), Obstruction of Governmental Administration 2 nd (Class A Misdemeanor) and Resisting Arrest (Class A Misdemeanor). Caver was transported to the Erie County Holding Center in lieu of \$500.00 Bail.

2/18	Love Rd.	Suspicious Person	Complainant states that a subject stated he was walking around looking for a school for several hours and appeared confused. Deputies located the subject and advised him.
2/18	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
2/18	Pin Oak Cr.	Suspicious Incident	Complainant states he was walking his dog and heard an alarm ringing at a residence nearby. Deputies checked the residence but were unable to locate the owners. Nothing appeared out of order.
2/19	Baseline Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
2/19	Grand Island Blvd.	Suspicious Person	Complainant stated there was a suspicious person walking around the Grand Island Plaza. Deputies checked the area but were unable to locate any persons acting suspiciously.
2/20	Grand Island Blvd.	Theft of Services	An Employee at Chateau Motor Lodge stated that a subject had not paid for his room for the last week. Deputies investigation led to the arrest of 36 y/o Michael Paul of Grand Island for Theft of Services (Class A Misdemeanor). Paul was transported to the Erie County Holding Center in lieu of \$250 bail.
2/20	Grand Island Blvd.	Larceny	Employees of Walgreens state that a known person stole various items from the store. Deputies investigation led to the arrest of 51 y/o Christine Riordan of Grand Island for Petit Larceny (Class A Misdemeanor). Riordan was issued an appearance ticket returnable to the Town of Grand Island Court.
2/21	Grand Island Blvd.	Criminal Mischief	Employees at Tim Hortons state that an unknown person drew graffiti on a mirror in the bathroom. Damage was listed as minor.
2/21	Whitehaven Rd.	Youth Activity	Complainant states that several youths were running around on the River Oaks Golf Course. Deputies checked the area but were unable to locate the subjects. No damage was reported.
2/22	Baseline Rd.	Animal Loose	Complainant states a dog was running loose in the neighborhood. The Dog Control Officer was notified.
