The Erie County Sheriff's Office responded to 168 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
1/23	Marilyn Dr.	Suspicious Person with Vehicle	The complainant states that a vehicle was parked in the street but running with people inside for the last 30 minutes during the late hours of the night. Deputies located the vehicle and advised the occupants who left without incident.
1/23	Whitehaven Rd.	Marijuana Possession	Following a traffic stop, Deputies arrested 24 y/o Nicholas Muoio of Grand Island for Unlawful Possession of Marijuana (violation) and traffic infractions. Muoio was issued an appearance ticket returnable to the Town of Grand Island Court.
1/23	Whitehaven Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
1/23	Spicer Creek Run	Suspicious Incident	The complainant states that someone entered her residence during the late hours of the night while she was home. Prior to the arrival of Patrol the complainant called back and stated it was her daughter in the residence and she no longer needed police assistance.
1/24	Ward Park Rd.	Suspicious Incident	The complainant states that a neighboring house is vacant and it appeared as though someone may have burglarized the house. Deputies confirmed with the owner the house is vacant and nothing of value was contained inside. No persons were located inside the premise and Deputies re-secured the doors.
1/24	Grand Island Blvd.	Larceny	Employees of Supercuts state that a subject stole a brush while at the business then walked out of the store. Deputies located the youth responsible who was brought back to the store with her parents and made restitution at the satisfaction of employees.
1/24	Love Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call at Sunoco. Deputies spoke with employees and determined it was an issue with the phone lines.
1/24	Bedell Rd.	Accident Hit & Run	The complainant states that another vehicle backed up into her car then fled the scene. Deputies checked the area but were unable to locate the vehicle by the description given. No injuries were reported.

1/24	East River Rd.	Suspicious Incident	The complainant states that he received a suspicious phone call from a male subject claiming to be from the Niagara Falls Police Department. The complainant hung up the phone and called 911 to report the incident. Deputies determined the call was most likely a prank or attempt to gain the complainant's personal information over the phone.
1/24	Alvin Rd.	Open Door	The complainant states that several doors were open to Fucillo Hyundai during the late evening hours while the business was closed. Deputies checked the premise and found no persons or signs of a disturbance inside.
1/25	East River Rd.	Suspicious Person	The complainant states that a male subject with a flashlight was walking through his backyard during the late hours of the night and claimed to be looking for a lost dog. Deputies located the subject nearby and confirmed his story. The subject was reunited with the dog after Patrol found it walking in the roadway.
1/25	Whitehaven Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.

1/25	I-190	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.

1/25	Town Hall Terr.	Welfare Check	Deputies responded to a report of a 911 hang up call at the Town Hall Terr apartment complex office. Deputies checked the premise but found no persons in need of emergency assistance.
1/26	East River Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had run out of fuel.
1/26	Grand Island Blvd.	Traffic Arrest	Following a traffic stop, Deputies arrested 48 y/o William Martin of Grand Island for Aggravated Unlicensed Operation 2 nd Degree (Class A Misdemeanor), and other traffic infractions after a DMV check showed his license was currently suspended. Martin was issued an appearance ticket returnable to the Town of Grand Island Court.
1/26	Beaver La.	Suspicious Incident	The complainant states he received a suspicious text message from a local number and the person on the other end stated they wanted to buy drugs.
1/26	South State Pkwy.	ATV Complaint	The complainant states that an ATV was operating on the bicycle path on the side of the road during the late evening hours. Deputies checked the area but were unable to locate the ATV.
1/26	Grand Island Blvd.	Drunk Driving	Following a traffic stop, Deputies arrested 38 y/o Dahl Bawuor of Grand Island for Driving While Intoxicated and other traffic infractions. Bawuor registered a .25% B.A.C. after submitting a sample of his breath for chemical analysis and was further charged with Aggravated Driving While Intoxicated due to the elevated reading. Bawuor was transported to the Erie County Holding Center in lieu of \$250 bail.

1/27	Whitehaven Rd.	Suspicious Incident	An employee of Noco states that it appeared a customer passed a fake \$1 bill during a transaction. Deputies determined the bill was real it had just been altered.
1/27	Fernwood La.	Suspicious Incident	The complainant states that he received several phone calls during the day from an out of state number claiming he was involved in a lawsuit. Deputies advised the complainant the call was most likely a scam.
1/28	Stony Point Rd.	Accident Injury	Deputies responded to a report of a 1 car motor vehicle accident involving a bicyclist. The bicyclist was transported to a local hospital with seemingly non-life threatening injuries.
1/29	Baseline Rd.	Animal Loose	The complainant states that 2 Labradors were running loose through the neighborhood. The Dog Control Officer was notified.
1/29	East River Rd.	Suspicious Person with Vehicle	Deputies located an occupied vehicle in Buckhorn State Park during the late hours of the night. The occupants were advised and left without incident.
