

## **Erie County Sheriffs Office Media Release Summary**

The Erie County Sheriff's Office responded to 191 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

3/19	Grand Island Blvd.	Welfare Check	Deputies responded to a report of a 911 hang up call at a local residence. Deputies spoke with the occupant and determined the call was a misdial.
3/19	Bedell Rd.	Noise Complaint	The complainant states that people were yelling in a nearby apartment. Deputies spoke with the occupants of the apartment in question and advised them.
3/19	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Kelly's Country Store. No injuries were reported.
3/19	Love Rd.	Marijuana Possession	Following a traffic stop, Deputies arrested 19 y/o Armand Swanson of Grand Island for Unlawful Possession of Marijuana (Violation) and a traffic infraction. A small amount of marijuana was discovered in a false bottom container within the vehicle. Swanson was issued an appearance ticket returnable to the Town of Grand Island Court.
3/20	Woodlee La.	Animal Loose	The complainant states she found a dog roaming the area. The Dog Control Officer was notified.
3/20	Woodlee La.	Suspicious Person	The complainant states that a male subject was outside talking on his phone and acting strange. Deputies checked the area but were unable to locate the subject by the description given.
3/20	Whitehaven Rd.	Deer Struck	Deputies responded to a report of a 1 car motor accident involving a deer. No injuries were reported.
3/21	Jenell Dr.	Suspicious Incident	The complainant states that while delivering papers he found a car door open with no one around. Deputies checked and determined the open door was an oversight.  The door was locked and closed by Patrol.
3/21	Staley Rd.	Animal Loose	The complainant states that a horse was running loose in the roadway. Prior to the arrival of Patrol, the owner was able to retrieve the horse without incident.
3/21	West Park Rd.	Attempted Burglary	The complainant states that sometime overnight, an unknown person attempted to break into his apartment.  Damage was observed on the door frame but no entry was made.

3/21	Autumnwood Dr.	Accident Hit & Run	The complainant states that sometime in recent days, an unknown person struck his mailbox with a vehicle and fled the scene.
3/21	Marilyn Dr.	Parking Violation	The complainant states that a vehicle was blocking the sidewalk while parked in the driveway of a residence.  Deputies made contact with the owner who agreed to move the vehicle.
3/22	East River Rd.	Suspicious Person with Vehicle	Deputies located an occupied vehicle parked at Fisherman's Landing during the late hours of the night.  The driver was advised and left without incident.
3/22	Warner Dr.	Suspicious Person	The complainant states that approximately 6 subjects dressed in dark clothes were running down the street during the late hours of the night. Deputies checked the area but were unable to locate any subjects matching the description.
3/22	Love Rd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident at the intersection of Baseline Rd. No injuries were reported.
3/23	Staley Rd.	Fraud	The complainant states she filed her tax return and was notified by the IRS that someone had already used her social security number to file taxes unlawfully on her behalf.
3/23	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident in the parking lot of Care A Lot Daycare Center. No injuries were reported.
3/23	East River Rd.	Deer Struck	Deputies responded to a report of a 1 car motor accident involving a deer. No injuries were reported.
3/24	West River Pkwy.	Suspicious Person with Vehicle	Deputies located an occupied vehicle parked on the overlook near Whitehaven Rd. The occupants were advised and left without incident.
3/24	Baseline Rd.	Narcotics / Marijuana Possession	Following a traffic stop, Deputies arrested 2 Juvenile Offenders for Unlawful Possession of Marijuana (violation). 1 of the Juvenile Offenders was additionally charged with 2 counts of Criminal Possession of a Controlled Substance 7 <sup>th</sup> Degree (Class A Misdemeanor). 1 subject was issued an appearance ticket returnable to the Town of Grand Island Court and the other was transported to the Erie County Holding Center in lieu of \$500 bail.
3/24	Wallace Dr.	Residential Fire	Deputies responded to assist the Grand Island Fire Department with a report of a house fire. No one was home when the fire started and no injuries were reported. The Erie County Sheriff's Office Fire Investigation Unit responded to assist in determined the cause and origin of the fire which was determined to be accidental.
3/24	Trails End	Suspicious Incident	The complainant states she heard a banging sound coming from her basement and thought someone was in the house. Deputies checked but found no persons inside.
3/24	Settlers Row	Suspicious Incident	The complainant states that she came home from work and found the front door wide open. Deputies checked the residence but found no persons or signs of a disturbance. The open door was determined to be an

			oversight.
3/24	I-190	Suspicious Person with Vehicle	Deputies located a suspicious vehicle parked on the side of the I-190 near the Baseline Rd. overpass. It was determined the vehicle had a flat tire and the driver pulled over to get out of the roadway.
3/25	Staley Rd.	Larceny	The complainant states that while he was working at Fresenius Kabi an unknown person(s) stole his cell phone from an office inside the business. Investigation Ongoing.
3/25	Grand Island Blvd.	Suspicious Incident	The complainant states he found an open door on a vacant commercial business. Deputies checked the premise but found no persons or signs of a disturbance inside.
