2/22	East River Rd.	Unknown Trouble	The complainant states he drove by 2 vehicles that were stopped in the roadway who may have been involved in an accident. Deputies checked the area but were unable to locate the vehicles.

2/26	Park La.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled at the intersection of Ransom Rd. AAA responded to tow the vehicle.
2/27	Bush Rd.	Welfare Check	The complainant states that 2 vehicles were parked a snowmobile launch site during the late hours of the night and was concerned the snowmobilers may have broken down in the freezing temperatures. Deputies located the owners of the vehicles and determined they had a sled break down on the trail and were having a difficult time getting the snowmobile back to the trailer.
