The Erie County Sheriff's Office responded to 176 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

4/5	East River Rd.	Larceny	The complainant states sometime in recent days, an unknown person(s) stole various items from her property.
4/5	Staley Rd.	Fraud	The complainant states that sometime in recent weeks, an unknown person(s) used his personal information to fraudulently file for taxes in his name. Information forwarded to the I.R.S.

Grand Island Fire Department reported 1 victim was found inside the apartment. The Erie County Sheriff's Office Fire Investigation Unit was requested by the Grand Island Fire Department for assistance in the investigation.
4/5	East River Rd.	Fireworks Use	The complainant states he heard several loud booms consistent with fireworks during the late evening hours. Deputies checked the area and determined the complaint to be unfounded.

Detig registered a .15% B.A.C. after submitting a sample of her breath for chemical analysis. Detig was issued an appearance ticket returnable to the Town of Grand Island Court and released to the custody of a sober 3 rd party.

Passanese was issued an appearance ticket returnable to the Town of Grand Island Court.
