The Erie County Sheriff's Office responded to 235 calls the week of this report. Below is a sampling of the noteworthy incidents in **Grand Island**.

Date	Type	Street	Narrative
4/18	Mental	Stonypoint Rd.	Deputies responded to a residence for a female acting delusional. Deputies spoke with the female and the caller. It was determined that the female was having an episode and needed to go to ECMC via ambulance for evaluation. Twin city and deputies escorted the female to ECMC CPEP.
4/20	Suspicious Incident – Car Break-Ins	Several Neighborhoods	Deputies took several calls in the early morning around 4:20AM in regards to a suspicious vehicle and suspicious males in the area of First St. and then in the Hennepin Rd. area. Deputies eventually found a vehicle on Hennepin Rd. The vehicle was found to be stolen recently from the City of Buffalo. The vehicle was unoccupied and contained belongings that appeared to be out of place. The vehicle was processed by detectives. Shortly later several individuals were located walking the area and one was in possession of a stolen credit card from a vehicle. Subject's were processed and released from the station. One subject was turned over to Kenmore PD for an outstanding warrant.
4/20	Fire - Residential	Pleasant Trail	State Police and Deputies responded to an address for smoke coming from the soffits outside the home. GI Fire responded for a working fire in the garage area. Residents were not home and cats were let out of the home by officer's. State Police is handling the investigation.
4/21	Confused Adult	Radisson Hotel	Deputies were called by taxi driver saying his fare is choking him. GIPD and deputies located the cab in the parking lot of the Radisson. The male passenger suffers from dementia and became irate when he didn't realize how he got there or where he was going. Officer's calmed him down and he was turned over to his wife without incident. Driver is not seeking charges.
4/23	Traffic Stop – Warrant Arrest	South State Pkwy @ Fix Rd.	Deputies initiated a traffic stop on a blue Ford SUV. The vehicle had a suspended registration. The driver was issued UTT's and released but the passenger had active warrants. Passenger was turned over to the Ontario County Sheriff's Dept.
4/24	Suspicious Vehicle – Possession of Stolen Property	Winkler Rd.	Deputies were called for an unknown vehicle in the caller's driveway. Officers arrived to find two males who appeared to be passed out and possibly intoxicated. Officer's later discovered that the vehicle they were operating was not theirs and they did not have permission to use it. Driver was arrested for UUMV and the vehicle was impounded and returned to the

			owner.
