The Erie County Sheriff's Office responded to 161 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

4/13	Bedell Rd.	Suspicious Vehicle	Complainant states that a vehicle pulled into Veterans Park and turned off its lights during the late hours of the night. Deputies located the vehicle, which was occupied by 1 individual who had pulled over to use his cell phone. The subject was advised.
4/13	Waterford Pk.	Pistol Permit Investigation	Deputies conducted a background check of an individual who applied for a pistol permit.
4/13	Second St.	Suspicious Vehicle	Complainant states that a suspicious vehicle was driving slowly up and down the street numerous times. Deputies checked the area but were unable to locate the vehicle.
4/13	Baseline Rd.	Animal Injury	Complainant states that a deer was in the roadway and appeared to be injured. Deputies checked the area but were unable to locate the animal.
4/14	Second St.	Disturbance	Complainant states that there were numerous people in the street and they appeared to be fighting. Deputies located the subjects involved and advised them. All parties stated that no fight had taken place only a loud verbal argument.
4/14	Park Pl.	Larceny	Complainant states that various jewelry was missing from her residence and believed that a known individual had stolen the items in question. Investigation Ongoing.
4/14	Grand Island Blvd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
4/14	East River Rd.	Larceny	Complainant states that various boats had items stolen from them sometime in recent months while they were at River Oaks Marina. Investigation Ongoing.
4/14	East River Rd.	Youth Activity	Complainant states that several youths were skateboarding at Fisherman's Landing. Deputies checked the area but were unable to locate the subjects.
4/15	South State Pkwy.	Refer to Patrol	Complainant states that it sounded as if a low flying helicopter was in the area. Deputies determined the noise to be coming from the South Grand Island Bridge work.

4/15	Staley Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
4/15	West River Rd.	Illegal Dumping	Complainant states that a dump truck was dumping debris in the roadway. Deputies checked the area but were unable to locate the truck or any debris in the roadway.
4/15	Grand Island Blvd.	Disorderly Person	Complainant states that a male subject was giving the middle finger to passing vehicles. Deputies located the subject and advised him.
4/15	Park Pl.	Criminal Mischief	Complainant states that a vehicle struck his mailbox and then left the scene in an unknown direction. While Deputies were looking for the vehicle, the driver returned and offered to pay restitution for the damages.
4/15	Bedell Rd.	Reckless Operation	Complainant states that a vehicle was swerving all over the roadway. Deputies checked the area but were unable to locate the vehicle.
4/15	Baseline Rd.	Animal Injury	Deputies responded to a report of a dog that had been struck by a vehicle. The dog was taken to the Grand Island Small Animal Hospital for treatment.
4/16	West River Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
4/16	Baseline Rd.	Residential Fire	Deputies assisted Grand Island Fire Department for a report of an oven fire.
4/16	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
4/17	Whitehaven Rd.	Suspicious Person	Complainant states that a male subject was on the property of the Grand Island Rod & Gun Club and was not supposed to be there. Deputies located the subject who was a member of the club and was out for a jog.
4/17	Harvey Rd.	Larceny	Complainant states that sometime during the night, an unknown person(s) stole various items from their unlocked vehicle.
4/17	Bedell Rd.	Suspicious Incident	Complainant states that the smell of marijuana was emanating from an apartment in her complex. Deputies checked but were unable to locate any subjects using marijuana.
4/17	East River Rd.	Suspicious Incident	Complainant states that it appeared that someone was dumping things into the Niagara River from his pickup truck. Deputies located the subject who owned the property and was doing yard work. No substances were dumped into the river.
4/17	Pin Oak Cr.	Suspicious Incident	Complainant states that 2 subjects came to her residence claiming to be representatives from National Fuel stating they needed to shut her gas off. The subjects did not shut the gas off and then left in an unknown direction. Deputies checked the area but were unable to locate the subjects. National Fuel advised the complainant that no employees were in that area today.
4/18	Bedell Rd.	Traffic Arrest	Following a traffic stop, Deputies arrested 33 y/o Scott Baker of Buffalo for Aggravated Unlicensed Operation 3 rd Degree after a DMV check showed his license was currently suspended. Baker was issued an appearance ticket returnable to the Town of Grand Island Court.

4/18	Riverdale Dr.	Larceny	Complainant states that an antique picture was missing from her garage. Investigation Ongoing.
4/18	Stony Point Rd.	ATV Operation	Complainant states that an ATV was operating on her property. Deputies located the driver of the ATV and advised him.
4/18	Bedell Rd.	Criminal Mischief	Complainant states that sometime in recent days, an unknown person(s) slashed a tire on his vehicle while it was parked in the apartment complex parking lot.
4/18	Bedell Rd.	Suspicious Incident	Complainant states that the smell of marijuana was emanating from an apartment in her complex. Deputies checked but were unable to locate any subjects using marijuana.
4/18	East River Rd.	Reckless Operation	Complainant states that a vehicle was driving slowly down the road and kept stopping in traffic. Deputies located the vehicle and spoke to the driver who was lost. Deputies assisted the driver in reaching his destination.
4/18	Baseline Rd.	Marijuana Possession	Following a traffic stop, Deputies arrested 28 y/o Gino Lamarco of Grand Island for Unlawful Possession of Marijuana (Violation). Lamarco was issued an appearance ticket returnable to the Town of Grand Island Court.
4/19	Laurie La.	Suspicious Vehicle	Complainant stated that a suspicious vehicle was driving up and down the street during the late hours of the night. Deputies checked the area but were unable to locate the vehicle.
4/19	Cox Rd.	Wires Down	Deputies responded to a report of a tree limb that had fallen which damaged electrical wires and a car. No injuries were reported.
4/19	Stony Point Rd.	Refer to Patrol	Complainant states that a tree limb had fallen on 2 vehicles in his driveway. No injuries were reported.
4/19	Sandy Beach Rd.	Suspicious Incident	Complainant states that he heard an unfamiliar male voice coming from inside of his house. Deputies checked the residence but found no subjects inside. No damage was reported and no items were missing.
