The Erie County Sheriff's Office responded to 183 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

3/22	Ransom Rd.	Open Door	While conducting a residential premises check of Ransom Rd., Deputies observed an open door on a home during the late hours of the night. Deputies spoke with the occupant and determined the door to be an oversight.
3/22	Ransom Rd.	Larceny	The complainant states that sometime in recent days, an unknown person(s) stole various items from his unlocked vehicle.
3/22	Whitehaven Rd.	Drunk Driving	Following a traffic stop, Deputies arrested 57 y/o Dana Boyle of Grand Island for Driving While Intoxicated and other traffic infractions. Boyle registered a .18% B.A.C. after submitting a sample of his breath for chemical analysis and was further charged with Aggravated Driving While Intoxicated due to the elevated reading. Boyle was issued an appearance ticket returnable to the Town of Grand Island Court and released to a sober 3 rd party.
3/22	West River Rd.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies spoke to the occupants and determined the call to be a misdial.
3/23	Revere Rd.	Attempted Break In	The complainant states that sometime during the night, an unknown person(s) attempted to break into her residence by cutting open a screen window. No entry seemed to be made. Investigation Ongoing.
3/23	South State Pkwy.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
3/23	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
3/23	Bush Rd.	Suspicious Vehicle	The complainant states that an unoccupied vehicle was parked on the side of the road for a majority of the day. Deputies checked the area but were unable to locate the vehicle.
3/23	Grand Island Blvd.	Suspicious Vehicle	Deputies located an occupied vehicle outside of a closed business during the late hours of the night. The occupant was determined to be an employee of the business.

3/26	Fix Rd.	Shots Fired	The complainant states that she heard multiple gun shots in the area. Deputies located several subjects who were target shooting and advised them.
3/26	Park Pl.	Illegal Dumping	The complainant states that a construction company was dumping debris on her property. The complainant was referred to the Town Building Inspector.
3/26	Fairview Ct.	Accident Injury	Deputies responded to a report of a 1 car motor vehicle accident involving a pedestrian. One person was transported to a local hospital for seemingly non-life threatening injuries.
3/26	Grand Island Blvd.	Suspicious Incident	Deputies located a person walking around the sales lot of a closed business. The subject stated he was in the market for a vehicle but did not like being hassled by salesmen. The subject was advised and left without incident.
3/25	Bedell Rd.	Suspicious Incident	The complainant states that she came home to her apartment and found her door open. Deputies checked but found no persons inside. Nothing was reported damaged or stolen.
3/25	Grand Island Blvd.	Criminal Mischief	The complainant states that various items were damaged at a local business sometime in recent days. Investigation Ongoing.
3/25	Whitehaven Rd.	Warrant Arrest	Deputies arrested 28 y/o Nicholas Lofaro of Hamlin NY after a check revealed he had an outstanding Bench Warrant from the Town of Grand Island. Hamlin was transported to the Erie County Holding Center.
3/25	South State Pkwy.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
3/25	East River Rd.	Suspicious Vehicle	The complainant states that a suspicious looking pickup truck was slowly driving through the neighborhood multiple times. The vehicle left in an unknown direction prior to the arrival of patrol. Deputies checked the area but were unable to locate the vehicle by the description given.
3/25	Baseline Rd.	Reckless Operation	The complainant states that a vehicle almost struck a school bus and the overpass while driving on the roadway. Deputies checked the area but were unable to locate the vehicle by the description given.
			Deputies arrested 26 y/o Keenan Murphy of Cheektowaga after a check revealed he had an outstanding Bench Warrant from the Town of Cheektowaga. Murphy was transferred to the custody of Cheektowaga Police Department.

3/27	Stony Point Rd.	Refer To Patrol	The complainant states that a child, who was not being supervised, almost ran into the roadway. Deputies spoke to the mother of the child and advised her.
3/28	Whitehaven Rd.	Suspicious Incident	The complainant states that a bottle filled with a suspicious liquid was sitting on the side of the road. Deputies determined the bottle was filled with a normal drinking liquid.
3/28	Cardinal La.	Suspicious Incident	The complainant states that a light on her neighbor's residence was blinking on and off like an alarm had been activated. Deputies checked the premise and determined the problem to be an electrical issue.
3/28	Love Rd.	Criminal Mischief	The complainant states her vehicle was damaged by an unknown person while she was at 711.
