The Erie County Sheriff's Office responded to 176 calls the week of this report. Below is a sampling of the noteworthy incidents on **<u>Grand Island</u>**.

3/23	Whitehaven Rd.	Customer Trouble	Employees at Holiday Inn state that several guests were causing a disturbance and refused to leave when asked by staff members. Deputies located the subjects and advised them. The subjects left without further incident.
3/23	Baseline Rd.	Suspicious Person	Deputies located a subject in the back of Dick and Jenny's Bake and Brew late at night. The subject was an employee opening the business for the day.

When he tried to return the dog, it appeared no one was home but the complainant stated that 3 young children looked to be home alone. Deputies checked and were able to speak to the homeowner who just didn't hear his neighbor knocking.
3/23	Stony Point Rd.	Accident PDO	Deputies responded to a report of a 1 car motor vehicle accident. No injuries were reported.
3/23	Alvin Rd.	Suspicious Vehicle	An employee at Fucillo Hyundai states that she found a truck on the lot that was running but no one was around it. Deputies located the vehicle which seemed to have been left running on accident.
3/23	Calvano Dr.	Welfare Check	Deputies responded to a report of a 911 hang up call. Deputies determined the call to be a mistake.
3/23	Fix Rd.	Suspicious Person	Complainant states that a suspicious male subject was standing on the lawn at his neighbor's house. Deputies checked the area but were unable to locate the subject. No damage was observed.
3/23	Wallace Dr.	Suspicious Vehicle	Complainant states that a vehicle pulled into her driveway late at night and began honking the horn. The vehicle left shortly after and Deputies located it nearby.

3/23	East River Rd.	Traffic Arrest	next door neighbor. Following a traffic stop, Deputies arrested 28 y/o Noemi Gonzalez of Buffalo, for Aggravated Unlicensed Operation 3 rd Degree and other traffic infractions. Gonzalez was issued an appearance ticket returnable to the Town of Grand Island Court.
3/24	Bedell Rd.	Suspicious Incident	Complainant states that a male subject was attempting to kick in the door of her apartment. Deputies spoke to the complainant on scene who then told Deputies that she called 911 because a male subject she did not know entered the apartment building and was concerned. The complainant was advised and her allegations were determined to be unfounded.
3/24	White Oak La.	Suspicious Incident	Complainant states that 3 subjects were knocking on the door of her residence during the late evening hours. Deputies located the subjects who had purchased a fridge from the complainant's husband and were there to pick it up.
3/25	Grand Island Blvd.	Loud Music	Complainant states that loud music was coming from an apartment inside of his complex. Deputies located the source of the music and advised the subjects to turn it down.

3/25	Bedell Rd.	Suspicious Incident	Complainant states that an unknown person was taping death threat letters on her apartment door. The complainant was unable to provide Patrol with any of the letters. Deputies determined her allegations to be unfounded.

3/26	Bedell Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
3/26	East River Rd.	Suspicious Incident	Complainant states that a vehicle full of youths was driving down the street and appeared to be throwing fireworks out of the windows of the vehicle. Deputies checked the area but were unable to locate the vehicle.
3/27	Bedell Rd.	Neighbor Dispute	Complainant states that a neighbor in her apartment complex was using the washing machine late at night. Deputies checked but were unable to locate any subjects using the laundry facilities.
3/27	Baseline Rd.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
3/27	Grand Island Blvd.	Accident PDO	Deputies responded to a report of a 2 car motor vehicle accident. No injuries were reported.
3/27	Bush Rd.	Open Door	Complainant states that a door was open to a residence and it did not appear anyone was home. Deputies checked and were able to secure the door. No damage was observed.
3/28	Timberlink Dr.	Suspicious Incident	Complainant states that several subjects rang his doorbell late at night and then fled. Deputies checked the area but were unable to locate any subjects. No damage was observed.
3/28	White Tail Run	Suspicious Vehicle	Complainant states that a suspicious vehicle with Ohio plates was parked on the street. Deputies located the vehicle but nothing appeared suspicious in nature.
