The Erie County Sheriff's Office responded to 130 calls the week of this report. Below is a sampling of the noteworthy incidents on **Grand Island**.

Date	Street	Type	Narrative
3/28	East Park Rd.	Suspicious Person	Deputies located 2 subjects walking through the neighborhood during the late hours of the night.
3/28	West River Pkwy	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled.
3/28	Baseline Rd.	Drunk Driving	Following a traffic stop, Deputies arrested 41 y/o Bridget Blake of Grand Island for Driving While Intoxicated and other traffic infractions. Blake registered a .15% B.A.C. after submitting a sample of her breath for chemical analysis. Blake was issued an appearance ticket returnable to the Town of Grand Island Court and released to the custody of a sober 3 rd party.
3/29	Staley Rd.	Harassment	The complainant states that a male subject was calling his residence and knocking on his door harassing him. The male subject was advised to cease all contact.
3/29	Ransom Rd.	Warrant Arrest	While investigating an unrelated complainant, Deputies arrested 2 subjects on outstanding warrants. 30 y/o Mark Hicks of Buffalo and 38 y/o Todd Ward of the City of Tonawanda were arrested after a check showed each had an outstanding warrant. Hicks was turned over to the Buffalo Police Department and Ward was turned over to the City of Tonawanda Police Department.
3/29	Grand Island Blvd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
3/30	Grand Island Blvd.	Larceny	The complainant states that one of his employees was caught stealing on the business' video surveillance system. Deputies spoke with all parties and it was agreed by the complainant that the property would be returned and the subject would no longer be welcome on the premise.
3/30	West River Pkwy.	Motorist Broke Down	Deputies assisted a motorist whose vehicle had become disabled due to transmission issues.

3/30	Whitehaven Rd.	Wires Down	Deputies responded to a report of wires down and arcing in the driveway of a residence. National Grid was

			notified.
3/30	Ransom Rd.	Suspicious Incident	The complainant states that several subjects appeared to be attempting to break in to a nearby vacant residence. The subjects left prior to the arrival of Patrol. Deputies checked the area but were unable to locate the subjects by the description given.
3/30	Brandywine Dr.	Suspicious Incident	The complainant states that several vehicles were stuck in the mud in a field off the roadway. Deputies located the vehicles nearby and advised the drivers.
3/31	Staley Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
3/31	Marjorie Dr.	Larceny	The complainant states that items were taken from her home after there was a fire at the residence in recent months.
3/31	West River Pwky.	Vehicle Off the Roadway	Deputies responded to a report of a vehicle that had become stuck in the snow on the seasonal road. The vehicle was winched out by Marty's Towing.
3/31	Warner Dr.	Criminal Mischief	The complainant states that an unknown person(s) caused damage to his shed by shooting BB's at it. Deputies were able to determine the BB's came from the neighbors who appeared to have accidentally struck the complainants shed. Both parties agreed to work out the incident among themselves and no longer required police assistance in the matter.
4/1	Grand Island Blvd.	Welfare Check	The manager of Chateau Motor Lodge states that he was unable to reach an occupant of a room and was concerned for her wellbeing. Deputies made contact with the occupant after knocking on the door.
4/1	Ransom Rd.	Parking Complaint	The complainant states that numerous vehicles were parking in an unauthorized area at the Grand Island High School. Deputies checked and determined no vehicles were parked illegally.
4/1	Baseline Rd.	Suspicious Incident	The complainant states that a male subject in a dark colored pickup truck was shooting deer from his vehicle using a shotgun. The vehicle was last seen headed westbound toward West River Rd. before the complainant lost sight of it. Deputies checked the area extensively but were unable to locate the vehicle by the description given.
4/2	Gregory Pl.	Barking Dog	The complainant states that a dog was barking at a nearby residence for the past few hours during the middle of the night. Deputies located the residence in question and advised the occupants who brought the dog inside.
4/2	Bedell Rd.	Larceny	The complainant states that sometime in recent weeks, an unknown person(s) stole various items of jewelry from his apartment.
4/2	Love Rd.	Suspicious Incident	The complainant states that she observed a drug transaction taking place in the parking lot of 711. The subjects and their respective vehicles left the area prior to the arrival of Patrol.
4/2	Westwood Dr.	Fraud	The complainant states that a known female subject used her credit card without her permission while at a store on

			Grand Island. Investigation Ongoing.
4/2	Queens Dr.	Suspicious Vehicle	The complainant states that a suspicious vehicle was parked on the street in front of his residence during the late evening hours and when he went to the front door the vehicle took off. Deputies checked the area but were unable to locate the vehicle by the description given.
4/2	West River Rd.	Deer Struck	Deputies responded to a report of a 1 car motor vehicle accident involving a deer. No injuries were reported.
4/3	Lakeview Dr.	Suspicious Incident	The complainant states that several subjects driving a dark colored van asked him if he had any scrap metal before leaving the area. The vehicle was last seen headed toward Deerwood Dr. Deputies located the vehicle nearby and spoke with the occupants who were scrappers. The subjects were advised and left the area without incident.
4/3	Marilyn Dr.	Suspicious Incident	The complainant states that a male subject was walking around a nearby vacant residence and appeared to take a lawn mower from the property before leaving in his vehicle. Deputies checked the premise and found no persons inside.
4/3	Grand Island Blvd.	Suspicious Vehicle	Deputies located a suspicious vehicle parked outside of a closed business during the late hours of the night. The driver was located inside of the business and it was determined he was the owner.
